RESOLUTION

1 A RESOLUTION concerning

2 Housing and Community Development

3 Annual Action Plan: FY 2013

4 For the purpose of approving and adopting the Prince George's County Fiscal Year 2013
5 Housing and Community Development Annual Action Plan consisting of federal programs,
6 including their federal funding applications which, along with other resources, serve to
7 implement housing and community development strategies set forth in the County's FY 2011-
8 2015 Consolidated Plan.

9 WHEREAS, under the terms of the Housing and Community Development Act of 1974, as
10 amended, Prince George's County is qualified as an urban county eligible to receive its thirty-
11 eighth year entitlement of Community Development Block Grant (CDBG) funds in the estimated
12 amount of \$4,225,520 and \$141,600 in Program Income for FY 2013; and

13 WHEREAS, as a federal requirement for the use of CDBG funds, project funding requests
14 were solicited from the public through various means including conduct of a public forum; and

15 WHEREAS, under the terms of the Cranston-Gonzalez National Affordable Housing Act of
16 1990, as amended, Prince George's County is qualified to receive its twenty-first year
17 entitlement of HOME Investment Partnerships (HOME) funds in the estimated amount of
18 \$1,499,086 and \$341,800 in Program Income for FY 2013; and

19 WHEREAS, under the terms of the Stewart B. McKinney Homeless Assistance Act of
20 1988, as amended, Prince George's County is qualified to receive its twenty-fifth year
21 entitlement of Emergency Solutions Grant (ESG) (formerly known as Emergency Shelter Grant)
22 Program funds in the estimated amount of \$472,562 and must provide an estimated \$472,562 in

1 matching funds for FY 2013; and

2 WHEREAS, the FY 2013 Annual Action Plan is based on HUD Federal Fiscal Year 2012
3 (County Fiscal Year 2013) estimated formula allocations and the County's final eligible funding
4 for FY 2013 has not been announced by HUD; and

5 WHEREAS, as a condition to the award of the above-referenced funds, U.S. Department of
6 Housing and Urban Development (HUD) regulations effective January 5, 1995, require Prince
7 George's County to prepare and transmit to HUD a five-year Housing and Community
8 Development Consolidated Plan: FY 2011-2015 (the "Consolidated Plan"); and

9 WHEREAS, the Consolidated Plan, adopted by CR-26-2010, was prepared following a
10 detailed citizen participation plan, identifies and assesses housing and community development
11 needs, incorporates a housing market analysis, and presents a strategic plan for addressing
12 priority needs; and

13 WHEREAS, pursuant to Subtitle 15A of the Prince George's County Code, as amended, the
14 County Executive transmitted a draft Annual Action Plan for Housing and Community
15 Development: FY 2013, incorporating the grant applications and the County Council duly
16 advertised and conducted a public hearing on the draft Annual Action Plan; and

17 WHEREAS, the County Council, in recognition of public testimony and on the basis of its
18 review and analysis of the draft Annual Action Plan, finds that said Plan generally conforms to
19 the provisions and intent of Subtitle 15A, as amended.

20 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
21 County, Maryland, that the draft "Annual Action Plan for Housing and Community
22 Development: FY 2013," a copy of which shall be marked for identification by the Clerk of the
23 County Council and maintained as a permanent record, is hereby approved, in accordance with
24 the activities described in the FY 2013 Budget Summaries and the draft FY 2013 Annual Action
25 Plan, Attachments "A" and "B", respectively, as attached hereto and made a part hereof.

26 BE IT FURTHER RESOLVED that the County Executive or his designee is hereby
27 authorized and empowered as the official representative of Prince George's County to submit the
28 approved "Annual Action Plan for Housing and Community Development: FY 2013" to HUD,
29 along with all assurances contained therein, to act as necessary in connection with the
30 submission, and to provide such additional information to HUD as may be required.
