RESOLUTION

A RESOLUTION concerning

The Enactment of a Certain Ordinance of the City of New Carrollton FOR the purpose of approving the enactment of Ordinance 07-19 amending Chapter 66 of the City of New Carrollton Code, concerning residential storage.

WHEREAS, the City Council of the City of New Carrollton, after a public hearing conducted on February 6, 2008, enacted Ordinance 07-19; and

WHEREAS, this Ordinance (which is attached hereto and incorporated herein as Attachment A, and hereinafter referred to as "Ordinance 07-19") amended the City of New Carrollton Code Chapter 66, Article 66-3; and

WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code authorizes municipalities within the Maryland-Washington Metropolitan District to enact ordinances concerning residential storage on land either zoned for residential or commercial use or adjacent to residential or commercial zones for the purpose of preserving, improving and protecting the general character and design of lands within the corporate limits of the municipality, provided that such ordinances impose stricter or additional limitations or restrictions than are otherwise imposed by the County zoning regulations; and

WHEREAS, Section 8-112.1 of Article 28 of the Maryland Annotated Code provides that such ordinance shall not be effective until approved by the County Council of Prince George's County, sitting as the District Council; and

WHEREAS, the City of New Carrollton, pursuant to Section 8-112.1 of Article 28 of the Maryland Annotated Code, has delivered certified copies of Ordinance 07-19 to the District

2	WHEREAS, the District Council has determined that the Ordinance 07-19 imposes		
3	additional conditions upon residential storage than those currently imposed by Subtitle 27 of the		
4	Prince George's County Code (the "Zoning Ordinance").		
5	NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's		
6	County, Maryland, sitting as the District Council for that part of the Maryland-Washington		
7	Regional District in Prince George's County, Maryland, that Ordinance 07-19 of the City of New		
8	Carrollton, as represented in Attachment A to this Resolution, be and the same is hereby		
9	approved.
