RESOLUTION

1 A RESOLUTION concerning

2 The 2018 Water and Sewer Plan (March 2022 Cycle of Amendments)

3 For the purpose of changing the water and sewer category designations of properties within the
4 2018 Water and Sewer Plan.

5 WHEREAS, Title 9, Subtitle 5 of the Environment Article of the Annotated Code of
6 Maryland requires the County to adopt a comprehensive plan dealing with water supply and
7 sewerage systems, established the procedures governing the preparation and adoption of said
8 plan, and provides for amendments and revisions thereto; and

9 WHEREAS, pursuant to said procedures, the County Executive submitted to the County
10 Council her recommendations on water and sewer plan amendment requests within the March
11 2022 Cycle of Amendments; and

12 WHEREAS, the County Council received testimony through an advertised public hearing
13 on the March 2022 Cycle of Amendments; and

14 WHEREAS, the County Council notified the Washington Suburban Sanitary Commission,
15 The Maryland-National Capital Park and Planning Commission, The State and County Health
16 Departments, the Maryland Department of Planning and the Maryland Department of the
17 Environment of the public hearing and provided each agency with copies of the March 2022
18 Cycle of Amendments.

19 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
20 County, Maryland, that the Prince George's County 2018 Water and Sewer Plan, as adopted by
21 CR-64-2019, and amended by CR-75-2019, CR-11-2020, CR-45-2020, CR-87-2020, CR-98-

1 2020, CR-22-2021, CR-49-2021, CR-87-2021, CR-105-2021 and CR-017-2022 is further
2 amended by adding the water and sewer category designations and Chapter 2 text amendments,
3 as shown in Attachment A and Attachment B, attached hereto and made a part hereof.*

4 BE IT FURTHER RESOLVED that maps identified as the “Prince George’s County,
5 Maryland, 2018 Water Map” and “Prince George’s County, Maryland, 2018 Sewer Map”, are
6 hereby amended to incorporate the approved category changes with the property location
7 delineated on the map in Attachment B, attached hereto and made a part hereof.

8 BE IT FURTHER RESOLVED that within five working days of the adoption of this
9 Resolution, it shall be transmitted to the County Executive by the Clerk of the Council.

10 BE IT FURTHER RESOLVED that this Resolution shall take effect on the day following
11 the first regularly scheduled Council meeting day which occurs after the County Executive
12 transmits her comments on the Resolution, or on the day that the County Executive indicates she
13 has no comments, or ten working days following the transmittal of this Resolution to the County
14 Executive, whichever shall occur first. Prior to the effective date of this Resolution, the Council
15 may reconsider its action based upon any recommendation received from the County Executive.

16 BE IT FURTHER RESOLVED that upon the effective date of this Resolution, it shall be
17 transmitted by the Clerk of the Council to the Secretary of the Maryland Department of the
18 Environment.
