BACKGROUND INFORMATION/FISCAL IMPACT:

This Resolution will amend the Prince George’s County Fiscal Year (“FY”) 2022 Annual Action Plan for Housing and Community Development by adding the Hill House at Beechfield project, an eligible activity not originally funded or described in the FY 2022 Annual Action Plan.

Additionally, this Resolution will amend the FY 2022 Annual Action Plan by reprogramming and reallocating One million dollars (\$1,000,000) in HOME Investment Partnerships (“HOME”) Program funds from the FY 2020 and FY 2021 Annual Action Plans to support the project.
