**PUBLIC SAFETY AND FISCAL MANAGEMENT COMMITTEE REPORT**   Date: 2/19/98

Committee Report: Favorable, 5-0, (In favor: Council Members Estep, Bailey, Hendershot, Scott and Wilson).

This Resolution will amend the Salary Plan in Salary Schedule I for the employees in the Family Connection Division, Department of Family Services bargaining unit, represented by AFSCME Local 2735 and reflects modifications of the two year collective bargaining agreement.

The highlights of the Salary Plan and the fiscal impact are included in CB-19-1998.
