RESOLUTION

1 A RESOLUTION concerning

2 Revenue Authority

3 For the purpose of approving the Revenue Authority's Statement of Procurement Policy and
4 Procurement Operating Procedures.

5 WHEREAS, the establishment of the Revenue Authority of Prince George's County
6 ("Revenue Authority") was authorized by CB-84-1997 pursuant to Chapter 491 of the Laws of
7 Maryland, 1996; and

8 WHEREAS, the Charter for the Revenue Authority was approved by the County Council
9 by CR-61-1998 and duly filed with the State of Maryland; and

10 WHEREAS, Section 5 of CB-84-1997 provides that the regulations of the
11 Revenue Authority shall be approved by the County Council by resolution; and

12 WHEREAS, at the Revenue Authority meeting held on August 2, 1999, the Revenue
13 Authority adopted the Statement of Procurement Policy by virtue of Resolution No. 1999-3,
14 attached hereto; and

15 WHEREAS, at the Revenue Authority meeting held on March 15, 2000, the Revenue
16 Authority adopted the Procurement Operating Procedures by virtue of Resolution No. 2000-1,
17 attached hereto; and

18 WHEREAS, at the Revenue Authority meeting held on September 27, 2000, the
19 Authority adopted amendments to the Statement of Procurement Policy and Procurement
20 Operating Procedures relating to the procurement of the services of experts and specialists,
21 which amendments were adopted by virtue of Resolution No. 2000-5, attached hereto.

1 WHEREAS, at the Revenue Authority meeting held on June 20, 2001, the Authority
2 adopted amendments to the Statement of Procurement Policy and Procurement Operating
3 Procedures to encourage minority business enterprise participation in the award of Authority
4 contracts and to assure that contractors and subcontractors meet local prevailing wage
5 requirements, which amendments were adopted by virtue of Resolution No. 2001-1, attached
6 hereto.

7 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
8 County, Maryland, that the Revenue Authority's Statement of Procurement Policy and
9 Procurement Operating Procedures, as amended, are hereby approved.
