Council Resolution 7 concerns County Council Rules of Procedure to amend Rules of Procedure for the County Council. Council Member Bland moved to suspend the Council Rules of Procedure to allow for the immediate adoption of Council Resolution 7; seconded by Council Member Olson. The motion carried by voice vote. (a) First Reading of Bills (Presentation)

<u>CB-4-2008 – AN ORDINANCE CONCERNING INDUSTRIAL ZONES</u> for the purpose of amending the regulations concerning certain industrial uses. - <u>PRESENTED</u>

Council Bill 4 was presented by Council Member Knotts and referred to the Planning, Zoning and Economic Development (PZED) Committee.

<u>CB-5-2008 - AN ACT CONCERNING THE ISSUANCE AND SALE OF SPECIAL</u>
<u>OBLIGATION</u> for the purpose of providing that special obligation bonds may be issued from time to time under the provisions of this Act in an amount not to exceed the aggregate principal amount of Thirty-Five Million Dollars (\$35,000,000) in order for the County to finance the construction of the infrastructure improvements as more particularly described herein; making

certain findings and determinations, among others, concerning the public benefit and purpose of such special obligation bonds; providing for the levy of a special tax in the form of a special hotel rental tax and the allocation of such special tax with respect to the special taxing district paid over to a special fund; providing that such special obligation bonds authorized to be issued hereby shall be payable from the amounts levied and deposited in a special fund, as described below, which include the special hotel rental taxes and that the special obligation bonds shall not constitute a general obligation debt of the County or a pledge of the County's full faith and credit or taxing power other than the taxes representing the Special Hotel Rental Tax (defined below); authorizing the County Executive of the County to specify, prescribe, determine, provide for and approve certain details, forms, documents or procedures in connection with such special obligation bonds issued hereunder and any other matters necessary or desirable in connection with the authorization, issuance, sale, delivery and payment of such special obligation bonds; authorizing the County Executive to take certain actions, to execute documents and make certain commitments on behalf of the County in connection with the issuance, sale and delivery of such special obligation bonds; authorizing the execution and delivery of such special obligation bonds and such other documents as may be necessary and desirable to effectuate the financing of the infrastructure improvements and the issuance, sale and delivery of such special obligation bonds; generally providing for, and determining various matters in connection with, the issuance, sale, delivery and payment of such special obligation bonds. **PRESENTED**

Council Bill 5 was presented by Council Member Knotts and referred to Public Safety and Fiscal Management (PSFM) Committee.

CR-8-2008 – A RESOLUTION CONCERNING FINANCIAL ASSISTANCE TO COMCAST OF MARYLAND, INC. FROM THE MARYLAND ECONOMIC

DEVELOPMENT ASSISTANCE FUND AND FROM PRINCE GEORGE'S COUNTY,

MARYLAND for the purpose of endorsing a \$500,000 and \$50,000 loan to Comcast of Maryland, Inc. ("Comcast") from the Maryland Economic Development Assistance Fund ("MEDAF") and Prince George's County, Maryland (the "County"), respectively, for costs associated with leasing office space for operation of a service center in the County.

Housing and Community Development for participation in the Department's Community Investment Tax Credit Program. - <u>INTRODUCED</u>

Council Resolution 9 concerns the State of Maryland Neighborhood and Community Assistance Program for the purpose of expressing approval of the project submitted by Housing Options & Planning Enterprises, Inc. ("HOPE"), to the Maryland Department of Housing and Community Development for participation in the Department's Community Investment Tax Credit Program. Council Resolution 9 was introduced by the Chairman at the request of the County Executive and referred to the Transportation, Housing and the Environment (THE) Committee.
