**RESOLUTION**

A RESOLUTION concerning

Compensation and Benefits - Police Civilian Employees

Association - Salary Schedule P, Schedule of Pay Grades

FOR the purpose of amending the Salary Plan of the County to reflect the terms of an amended labor agreement by and between Prince George's County and the Police Civilian Employees Association.

WHEREAS, pursuant to Section 903 of Article IX of the Prince George's County Charter and Section 16-125(a) of the Prince George's County Code, amendments to the County's Salary Plan are to be submitted to the County Council in resolution form; and

WHEREAS, the Salary Plan must at this time be amended by the approval of a salary schedule to reflect the terms of an amended labor agreement by and between Prince George's County and the Police Civilian Employees Association; and

WHEREAS, pursuant to Charter 903, the County Executive has

recommended and submitted such amended salary schedule to allow benefit modifications;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the salary schedule submitted and recommended by the County Executive on April 18, 1990, which is attached hereto and made a part hereof, setting forth a modified pay plan effective July 2, 1989, which includes increases in base hourly rates by four percent (4%) effective July 2, 1989 and five and fourteen one hundredths percent (5.14%) effective July 1, 1990; upward adjustments of the maximum rates of pay by three and one-half percent (3 1/2%) effective July 2, 1989, and July 1, 1990; and further establishing the workweek and number of productive hours therein, work schedules, pay in excess of base salary, leave provisions, incentive awards, unemployment insurance, retirement contributions, group health and life insurance, social security, worker's compensation, and clothing and maintenance allowance, for such employees, be and the same is hereby approved.
