LEGISLATIVE HISTORY

FISCAL POLICY & GOVERNMENT OPERATIONS COMMITTEE

DATE: 6/17/92

Committee Vote: Favorable as amended, 4-0 (In favor: Council Members MacKinnon, Bell, Del Giudice and Fletcher).

The resolution amends the Salary Plan for Police Civilian Employees Association--Salary Schedule P.

Highlights of the agreement:

- (1) 8% COLA -- 6/92 - 6/93.
- (2) No new COLA in FY 93.
- (3) No more than two (2) days or sixteen (16) hours of furlough in FY 93.

- (4) Increase in supplemental retirement for up to twenty-five years of service from 10% to 15%.

Proposed amendments:

- (1) On page 2, line 1, delete "(14)" and insert "(28)".
- (2) On page 2, line 8, delete "(ten)" and insert "(eight)" and delete "May 2" and insert "March 7".
- (3) On page 2, line 15, insert the following new language:

"BE IT FURTHER RESOLVED that the provisions of this resolution shall supersede the provisions of CB-13-1992."

- (4) Salary Schedule P - Schedule of Pay Grades.

(A) On pages 1 and 4, delete "June 14" and insert "June 28".

(B) On page 9, Min-Max System, (F), delete "(14)" and insert "28".

- (5) Addendum to Memorandum of Understanding.

BACKGROUND INFORMATION/FISCAL IMPACT

This is a companion legislation based on renegotiation of the Collective Bargaining Agreement between Prince George's County and the Police Civilian Employees Association (PCEA) reflecting the terms of the Agreement.
