AFFECTED CODE SECTIONS:**BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution will amend the Prince George's County Fiscal Year ("FY") 2020 Annual Action Plan for Housing and Community Development by adding new Community Development Block Grant COVID-19 Round 3 ("CDBG-CV") Program activities, eligible activities not originally funded or described in the FY 2020 Annual Action Plan.

As part of the efforts to address a wide variety of needs including providing shelter to homeless individuals, increasing affordable housing options, and maintaining crucial public services during the current public health outbreak (COVID-19), Congress designated funding to federal entitlement programs, allocated through the U.S. Department of Housing and Urban Development ("HUD"). Specifically, Prince George's County is designated to receive additional funding totaling \$4,086,220 in Community Development Block Grant Program COVID-19 Round 3 Funds.

This Resolution requires at least one (1) public hearing because the proposed amendment to the FY 2020 Annual Action Plan would constitute a "substantial change" under the FY 2021-2025 County Citizen Participation Plan, as described in the County's FY 2021-2025 Consolidated Plan.
