For the purpose of approvi	ng Energy Savings and Lease Financing agreements for the purchase,
installation and financing o	f certain energy efficient equipment that is guaranteed to reduce
Prince George's County ("C	County") energy consumption and maintenance costs at County
building sites.	
WHEREAS, pursuant	to Section 819 of the Charter for Prince George's County, Maryland,
the County Council must a	pprove all multiyear contracts exceeding an aggregate of Five
Hundred Thousand Dollars	(\$500,000.00); and
WHEREAS, the Cour	nty desires to contract with certain energy savings companies,
specifically, Pepco Energy	Services, Inc. ("Pepco") and Johnson Controls, Inc. ("JCI"), to
design, install and maintain	energy savings equipment (the "Equipment") that is guaranteed to
yield to the County, energy	savings over a fifteen (15) year period, and to provide project
management, monitoring a	nd verification of guaranteed energy savings and other services
pursuant to the terms and c	onditions contained herein as Attachments A and B; and
WHEREAS, the Cour	nty desires to lease with the option to purchase from Grant Capital
Management, Inc. the Equi	pment to be purchased from Pepco and JCI pursuant to a Master
Lease having the terms and	conditions contained herein as Attachments C and D; and
WHEREAS, the Cour	nty desires to utilize escrow services for making progress payments to
the energy savings compan	ies for construction related to Equipment installation.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County,

Maryland that the contracts having the terms and conditions described in Attachments A, B, C and D be and the same are hereby approved, pursuant to Section 819 of the Charter.

SECTION 2. BE IT FURTHER ENACTED that the County Executive is hereby authorized to make any modifications, adjustments, corrections or any other changes as may be necessary to finalize any of these contracts in any manner the County Executive may deem necessary or proper but not altering their substance.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.

PRINCE GEORGE'S COUNTY ENERGY PERFORMANCE CONTRACT PEPCO ENERGY SERVICES TERM SHEET

CONSTRUCTION AND INSTALLATION OF ENERGY SAVING EQUIPMENT

Total Project Capital Cost (for energy project management, equipment and construction): \$3,171,619

Amount County shall pay from CIP Funds: \$347,718 (County to pay Pepco in 3 installments during first 90 days after construction begins)

Annual Guaranteed Energy Savings: \$266,564 of energy/utility bill savings per year (so long as equipment is used and maintained in accordance with the agreement. Savings amount increased 3% per year based on assumed rising energy prices.)

SAVINGS VERIFICATION SERVICES

Pepco Monitoring & Verification Services Term: 13 year term (services to measure and verify that the savings promised actually occur)

Pepco Monitoring & Verification Services Cost: \$10,600 per year (paid by County at end of each guarantee year. Cost increases 3% each year after Year #1.)

COUNTY COUNCIL REPORTING

Within ninety (90) days of the end of each Guaranteed Savings year, the Office of Central Services shall forward to the County Council the Annual Reconciliation Reports, a report detailing any irregularities/issues observed through the Monitoring and Verification processes, and any reports containing recommendations of the Energy Savings Companies, Project Management and/or County Energy Manager regarding the Energy Savings Project progress, shortfalls in guaranteed energy savings and adjustments to the Energy Savings equipment.

AUDITS AND INVESTIGATIONS

The Office of Audits and Investigations for Prince George's County, Maryland shall monitor the progress of the Energy Savings Projects and report annually its findings to the County Council.
