**ZONING BILL**

AN ORDINANCE concerning

Pet Supply and Feed Stores

FOR the purpose of establishing "pet supply and feed store" as a use, and permitting this use in the I-1 and I-2 Zones.

BY repealing and reenacting with amendments:

Sections 27-461(b) (1) (E), and  
27-473(b) (1) (E),

SECTION 1. BE IT ENACTED by the County Council of Prince

George's County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that Sections 27-461(b) (1) (E) and 27-473(b) (1) (E) of the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code, be and the same are hereby repealed and reenacted with the following amendments:
