RESOLUTION

1 A RESOLUTION concerning

2 State of Maryland Community Investment Tax Credit Program

3 For the purpose of approving the proposal submitted by CASA de Maryland, Inc. (“CASA”) to
4 the Maryland Department of Housing and Community Development for participation in the
5 Community Investment Tax Credit (“CITC”) Program.

6 WHEREAS, Section 6-401 through Section 6-406 of the Housing and Community
7 Development Article, Annotated Code of Maryland, established the Neighborhood and
8 Community Assistance Program to assist nonprofit organizations in carrying out approved
9 projects in designated revitalization areas, to encourage businesses to invest in priority funding
10 areas, and to strengthen public-private partnerships; and

11 WHEREAS, Section 6-404 of the Housing and Community Development Article,
12 Annotated Code of Maryland, provides for the allocation of tax credits to business entities or
13 individuals that contribute to approved projects of nonprofit organizations that provide services
14 to priority funding areas; and

15 WHEREAS, Section 6-405(c) of the Housing and Community Development Article,
16 Annotated Code of Maryland, provides that the Maryland Department of Housing and
17 Community Development may not approve a proposal for participation in the Neighborhood and
18 Community Assistance Program unless the proposal is approved by the governing body or
19 authorized designee of each county, municipal corporation or political subdivision that includes
20 any of the priority funding areas that benefits from the project; and

21 WHEREAS, CASA, a nonprofit organization based in the Prince George’s County,
22 proposes to use the tax credits under the CITC Program to expand its Maryland Bilingual

1 Education Program (the “Program”); and

2 WHEREAS, the Program strives to improve economic opportunities and social integration
3 for immigrants and low-income individuals by furthering adult education, as summarized in
4 “Attachment A,” attached hereto and made part hereof; and

5 WHEREAS, the Program provides educational services to residents that live in priority
6 funding areas within Prince George’s County; and

7 WHEREAS, CASA submitted a proposal to the Maryland Department of Housing and
8 Community Development for participation in the CITC Program and has requested an allocation
9 of tax credits in the amount of fifty thousand dollars (\$50,000.00) to expand the Program; and

10 WHEREAS, the County Executive expresses approval of the Program.

11 NOW, THEREFORE, BE IT RESOLVED that the County Council of Prince George’s
12 County, Maryland hereby expresses approval of the proposal submitted by CASA de Maryland,
13 Inc. to the Maryland Department of Housing and Community Development for participation in
14 the Community Investment Tax Credit (“CITC”) Program, as set forth in Attachment A.

15 BE IT FURTHER RESOLVED that copies of this Resolution shall be sent by the Clerk of
16 the Council to the County Executive, CASA de Maryland, Inc. and the Secretary of the Maryland
17 of the Department of Housing and Community Development.
