CHARTER AMENDMENT

1 AN ACT concerning

2 Amendment of Section 607, Charter of Prince George's County

3 For the purpose of proposing an amendment to Section 607 of the Charter of Prince George's
 4 County to include County law for the encouragement and support of local and minority businesses
 5 consistent with requirements of Federal, State, and County law; and generally regarding local and
 6 minority businesses.

7 BY proposing an amendment to:

8 Section 607,

9 Charter of Prince George's County, Maryland.

10 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
 11 Maryland, that the following amendment to Section 607, Charter of Prince George's County,
 12 Maryland, is hereby proposed:

13 **Sec. 607. Local and Minority Business.**

14 The County is committed to the encouragement and support of local and minority businesses
 15 consistent with requirements of Federal, [and] State, and County law.

16 SECTION 2. BE IT FURTHER ENACTED that a copy of this Act be transmitted to the
 17 County Executive for publication and that a copy also be transmitted to the Board of Supervisors
 18 of Elections for submission of the proposed amendment to the voters of this County at the 2022
 19 General Election pursuant to Section 1105 of the Charter.

20 SECTION 3. BE IT FURTHER ENACTED that the question of adoption of this proposed

1 Charter Amendment shall be submitted to the voters of the County at the General Election
2 occurring on November 8, 2022, and shall be placed on the ballot in the following form:

3 PROPOSED CHARTER AMENDMENT

4 To include County law for the encouragement and support of local and
5 minority businesses consistent with requirements of Federal, State, and
6 County law.

Adopted this 5th day of July, 2022, by an affirmative vote of two-thirds of the members of
the full County Council.
