WHEREAS, CR-98-2010 requires that, prior to the issuance of tax increment financing bonds, this County Council must review the TIF proposal and certifications by the developer, the

Resolution, and, if necessary, from amounts levied and deposited in the Special Taxing District

Fund established by the Formation Resolution, were authorized to finance said infrastructure;
