**RESOLUTION**

1 A RESOLUTION concerning

2 The Prince George’s County Literacy Commission

3 For the purpose of extending the deadlines for the submission of preliminary and final  
4 recommendations by the Prince George’s County Literacy Commission and extending the  
5 commission’s initial term established by CR-088-2025.

6 WHEREAS, the County Council adopted CR-088-2025, which established the Prince  
7 George’s County Literacy Commission to develop strategic initiatives to improve literacy  
8 outcomes for residents of Prince George’s County; and

9 WHEREAS, CR-088-2025 required the commission to submit preliminary  
10 recommendations to the County Council by March 27, 2026, and final recommendations by June  
11 2, 2026, and provided for the Commission’s initial term to expire on June 3, 2026; and

12 WHEREAS, additional time is necessary to ensure that the commission’s recommendations  
13 are thoroughly developed, incorporate stakeholder input, and reflect best practices for improving  
14 literacy outcomes countywide; and

15 WHEREAS, the County Council finds that granting additional time to the Prince George’s  
16 County Literacy Commission is reasonable and in the public interest.

17 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George’s  
18 County, Maryland, that the deadline established in CR-088-2025 for submission of the  
19 commission’s preliminary recommendations to the County Council is hereby extended  
20 from March 27, 2026, to September 30, 2026.

21 BE IT FURTHER RESOLVED that the deadline established in CR-088-2025 for

1 submission of the Commission’s final recommendations to the County Council is hereby  
2 extended from June 2, 2026, to December 15, 2026.

3 BE IT FURTHER RESOLVED that the initial term of the Prince George’s County Literacy  
4 Commission is hereby extended from June 3, 2026, to December 31, 2026.

5 BE IT FURTHER RESOLVED that the Clerk of the County Council shall send copies of  
6 this resolution to all enumerated departments, institutions, and organizations listed in CR-088-  
7 2025.
