1 AN ACT concerning

2 County Income Tax

3 For the purpose of reducing the County income tax rate in 2% increments, beginning January 1,  
 4 2000.

5 BY repealing and reenacting with amendments:

6 SUBTITLE 10. FINANCE AND TAXATION.

10 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
 11 Maryland, that Section 10-193 of the Prince George's County Code be and the same is hereby  
 12 repealed and reenacted with the following amendments:

13 SUBTITLE 10. FINANCE AND TAXATION.

14 DIVISION 8. TAX ASSESSMENT, LEVY, AND COLLECTION.

15 Subdivision 1. Income Tax.

16 **Sec. 10-193. County Income Tax.**

17 Pursuant to Tax-General Article, Section 10-106, Annotated Code of Maryland, as  
 18 amended, each County shall establish a County income tax equal to at least twenty percent (20%)  
 19 and not more than sixty percent (60%) of the State income tax for an individual. The County  
 20 income tax is established in an amount equal to fifty-eight percent (58%) [sixty percent (60%)]  
 21 of the Maryland State income tax for an individual for each of the residents of Prince George's

County effective January 1, [1995] 2000. The rate shall be fifty-six percent (56%), effective January 1, 2001; fifty-four percent (54%), effective January 1, 2002; and fifty-two percent, effective January 1, 2003. The rate shall be set at fifty percent (50%) of the Maryland State income tax for an individual effective January 1, 2004.

SECTION 2. BE IT FURTHER ENACTED that the Clerk of the Council shall notify the Comptroller of the rate change and the effective date of the rate change set by this Act on or before July 1, 1999.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
