BILL

1 AN ACT concerning

2 The Repeal of the Northern Gateway Business Improvement District

3 For the purpose of repealing the establishment of a business improvement district in the Northern
 4 Gateway.

5 WHEREAS, this legislation would delete the Business Improvement District (BID) in
 6 Langley Park; and

7 WHEREAS, CB-74-2022, the previous legislation, was passed with inaccurate language
 8 and is no longer needed or accurate as the State has passed new and improved framework for
 9 Prince George's to create BIDs; and

10 WHEREAS, State legislation has lowered the threshold to create BID and will now allow
 11 the county to start the process; and

12 WHEREAS, CB-74-2022 is not only inaccurate but no longer required.

13 NOW, THEREFORE, BE IT ENACTED by the County Council of Prince George's
 14 County, Maryland, that this current legislation would delete the Business Improvement District
 15 (BID) in Langley Park

16 BY repealing

17 SUBTITLE 10. FINANCE AND TAXATION.

18 Sections 10-339, 10, 340, 10-341, 10-342, 10-343

19 10, 344, 10-345, 10-346, 10-347

20 The Prince George's County Code

21 (2023 Edition).

1 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
2 Maryland, that Sections 10-339, 10, 340, 10-341, 10-342, 10-343, 10-344, 10-345, 10-346 and
3 10-347 of the Prince George's County Code be and the same are hereby repealed.

4 SECTION 2. BE IT FURTHER ENACTED by the County Council of Prince George's
5 County, Maryland, that Sections 10-339, 10, 340, 10-341, 10-342, 10-343, 10-344, 10-345, 10-
6 346 and 10-347 of the Prince George's County Code be abrogated and is of no full force and
7 effect.

8 * * * * * * *

9 SECTION 3. BE IT FURTHER ENACTED that the provisions of this Act are hereby
10 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,
11 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of
12 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining
13 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this
14 Act, since the same would have been enacted without the incorporation in this Act of any such
15 invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection,
16 or section.

17 SECTION 4. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
18 calendar days after it becomes law.
