**RESOLUTION**

1 A RESOLUTION concerning

2 Acting Chief Administrative Officer

3 For the purpose of extending the appointment of Mr. Major Riddick, Jr. as Acting Chief  
4 Administrative Officer.

5 WHEREAS, Section 505 of the Charter of Prince George's County, Maryland, provides for  
6 the County Executive to make a temporary appointment to the position of Chief Administrative  
7 Officer for Prince George's County if such a position shall become vacant; and

8 WHEREAS, by Executive Order No. 19-2018, Mr. Major Riddick, Jr. was appointed as  
9 Acting Chief Administrative Officer for Prince George's County, effective December 3, 2018;  
10 and

11 WHEREAS, Section 505 further provides that such appointment may be extended an  
12 additional four months by resolution of the County Council; and

13 WHEREAS, by CR-6-2019, and pursuant to this same section of the Charter, the County  
14 Council extended this appointment by four calendar months, to May 29, 2019; and

15 WHEREAS, as authorized by Section 505 of the Charter of Prince George's County,  
16 Maryland, the County Executive temporarily reappointed Major Riddick, Jr. as Acting Chief  
17 Administrative Officer pursuant to Executive Order No. 19-2019, effective May 30, 2019; and

18 WHEREAS, Section 505 of the Charter further allows a person to serve in a temporary  
19 appointment for no more than one year without an intervening permanent appointment; and

20 WHEREAS, the search for a permanent Chief Administrative Officer is continuing; and

21 WHEREAS, a continuation of Mr. Major Riddick, Jr. as Acting Chief Administrative  
22 Officer is in the best interests of the County to ensure continuity of government operations.

1           NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
2 County, Maryland, that the appointment of Mr. Major Riddick, Jr. as Acting Chief  
3 Administrative Officer be and the same is hereby extended for a period of up to four calendar  
4 months effective July 30, 2019 and ending on November 30, 2019.
