Anthony Jones is an accomplished attorney with extensive experience serving at the highest levels of the federal government, specializing in administrative law, ethics, grant oversight, and regulatory compliance. He previously served as General Counsel at the White House Office of National Drug Control Policy (ONDCP), where he served as the chief legal officer responsible for overseeing all legal matters related to the development and implementation of national drug control policy. In this role, Mr. Jones provides comprehensive legal guidance to senior leadership, supervises attorneys and legal staff, and manages litigation, ethics compliance, personnel issues, appropriations law, and Freedom of Information Act (FOIA)/Privacy Act obligations.

Since joining ONDCP in 2018, Mr. Jones has held several key legal positions, including Deputy General Counsel and Attorney Advisor. As Deputy General Counsel, he has overseen legal strategy for ONDCP's federal grant programs, which allocate more than \$450 million annually for prevention, treatment, and law enforcement initiatives. He has also served as the agency's primary legal liaison to Congressional committees, the Government Accountability Office, and the Office of Government Ethics, ensuring compliance and accountability across all programs. His leadership was instrumental in guiding ONDCP through critical reauthorization legislation and in shaping policy responses to the national drug overdose epidemic.

Earlier in his tenure at ONDCP, Mr. Jones played a pivotal role in advising leadership and Congressional committees on amendments to the agency's reauthorization statute, ensuring ONDCP's ability to effectively carry out its mission. He served as primary counsel for major grant programs such as the Drug-Free Communities Program and the High Intensity Drug Trafficking Areas Program, providing legal guidance that strengthened program integrity and impact nationwide.

In this role, he contributed to the development, promulgation, and enforcement of workplace safety and health standards and litigated precedent-setting cases that advanced protections for American workers.

Throughout his career, Mr. Jones has consistently demonstrated the ability to navigate complex statutory and regulatory frameworks while advancing the missions of federal agencies. His expertise, integrity, and commitment to public service have made him an invaluable leader and advisor in government, ensuring that critical national priorities are supported by sound legal foundations.

Mr. Jones' extensive experience in managing legal teams, advising senior leaders, and ensuring compliance with the complex statutory and regulatory requirements makes him uniquely qualified to serve as County Attorney. He brings not only deep legal expertise but also the vision, impartial judgment, and strong ethical leadership necessary to protect the interest of Prince George's County residents.
