SECTION 1.	BE IT ENACTED by the County Council of Prince George's County,
Maryland, that Sec	tion 2-503.01 of the Prince George's County Code be and the same is hereby

Beginning with	the 2025 calendar year, any youth employment program, including

employment, enrichment, and training programs, funded in-whole or in-part by the Prince George's County Government shall reserve at least fifty percent (50%) of the positions for Underserved Youth subject to the following:

- (a) <u>Underserved Youth</u> shall have the following meaning for this section: any youth and young adults from households making thirty percent (30%) or less of the Median Family Income (MFI) for the Washington DC Metropolitan Statistical Area (MSA) as published annually by the U.S. Department of Housing and Urban Development (HUD).
- (b) Household income may be determined based on the household's most recently filed tax returns, provided they were filed for one of the most recent three (3) calendar years.
- (c) The Director of Human Resources Management or other designee of the County

 Executive may also establish an alternative method of income verification for those households

 who have not filed taxes for any of the most recent three (3) calendar years.
- (d) The Director of Human Resources Management or other designee of the County

 Executive may establish a time threshold after which positions reserved for underserved youth

 by this Section may become available to a broader population. Such a time threshold shall not be
 sooner than twenty-one (21) calendar days after the opening date for application to the respective
 youth employment program.

SECTION 2. BE IT FURTHER ENACTED that the provisions of this Act are hereby declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph, sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this Act, since the same would have been enacted without the incorporation in this Act of any such invalid or unconstitutional word, phrase, clause, sentence, paragraph, subparagraph, subsection, or section.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
