Michael Calomese, Project Manager and Planner III, Master Plans and Studies Section, M-NCPPC, introduced Kierre McCune, Supervisor, Long Range Planning, M-NCPPC, and provided a brief overview of the Southern Green Line Station Area Sector Plan Minor Plan Amendment.
