RESOLUTION

A RESOLUTION concerning

Financing of Villages of Laurel

FOR the purpose of approving the financing of rehabilitation and equipping of the Villages of Laurel Apartments project by the Community Development Administration (CDA).

WHEREAS, there is a significant need for quality housing units i

n Prince George's County for families of limited incomes; and

WHEREAS, the Villages of Laurel Limited Partnership proposes to rehabilitate and equip a rental housing project to contain approximately 128 units, known as Villages of Laurel Apartments, on a site situated at 321 Thomas Drive in Laurel, Maryland; and

WHEREAS, the CDA has received an application package from the Villages of Laurel Limited Partnership for financing of Villages of Laurel in an amount not to exceed Six Million Dollars (\$6,000,000)

pursuant to its authority under Section 2-201 et seq. 2-208 of Article 83B of the Annotated Code of Maryland; and

WHEREAS, the regulations of CDA require that all projects fina

nced by it be approved by the governing body of the locality in which the project is situated; and

WHEREAS, the County Executive has recommended approval of the financing of the Villages of Laurel Apartments project;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the financing for rehabilitation and equipping proposed by CDA of the Villages of Laurel Apartments project is hereby approved in an amount not to exceed Six Million Dollars (\$6,000,000).
