PROGRAM MANAGEMENT

- 12. Please provide a list of the PGAHC's major FY 2024 goals and key objectives for each Division.
 - a. For each goal and objective, please provide a status report on the progress that has been made, to date, in achieving the respective goal and objective.

Goal 1. To provide Prince George's County residents and visitors with diverse and highquality arts experiences, cultural engagement, and humanities programming with a focus on equity and inclusion.

STATUS: PGAHC has continued its efforts to support and engage its creative community and residents with diverse and high-quality arts experiences, cultural engagements and humanities programming including a few highlighted below.

Objective 1.1: To enhance equitable learning environments with a focus on increasing high quality arts in education programs that support and enrich learning priorities for students and teachers and diverse cultural experiences for K-12 aged children.

PGAHC provides grants and programs for Artists-in-Residency in PGPCS and other schools and other community-based arts and cultural programs serving K-12 grade aged children. In FY 2024, PGAHC has launched two innovative and creative youth arts youth arts education programs in PGCPS schools. Youth Artist and Musicians Zone (YAMZ) as is an innovative program led by artist, arts educator, Tamara Wellons that uses the arts to foster a love for learning, leading to improved academic performance and positive youth developments, where children are encouraged to get in their creative zone as part of their academic engagement. YAMZ started in September at Chillum Elementary School, and we hope to expand it to other schools. To date YAMZ serves about 375 Students and has trained and works with 8 teachers during the school year. Neuro Blooms is a new creative arts program mental health awareness and inclusion for PGCPS high school students and uses the power of art to make mental health conditions visible and beautiful. Neuro Blooms imagery is based on brain scans of people with different mental health conditions. It is led by artist and PGAHC FY 2021 grantee, Leslie Holt, who used her grant to translate her artwork into mental health education materials in English and Spanish. Her program was introduced at PGCPS's Mental Health Conference in August 2023 and will launch formally this Spring at Duval High School with a public art installation, and ongoing classroom sessions. It will expand to four additional schools: Eleanor Roosevelt, Central, Oxon Hill and Northwestern. Neuro Blooms is also part of the County's Mental Health and Neurodiversity Action Group, which includes student representatives from each of the five schools listed above which has been meeting regularly since May 2023 to discuss/develop strategies to destignatize mental health conditions and support students in getting help.

The Organic Canvas: Farm-to-Frame: Held at Arts'tination this past February, this event exemplified our commitment to youth empowerment and creative expression. This innovative event was a remarkable success, engaging young residents in a transformative artistic experience that bridged the gap between agriculture and art. "The Organic Canvas" provided a platform for young people to express themselves creatively and develop a deeper appreciation for the environment. By fostering a connection between agriculture and art, the event empowered participants to explore new avenues of self-expression and environmental stewardship.

Office of the Prince George's County Poet Laureate: In February 2024, Khadijah Ali-Coleman, County Poet Laureate, presented poetry, literary history, and books at the beautiful new Bladensburg library for the Bladensburg mayor's youth focused Black History Month program.

Annual March and April Youth Art Month - PGAHC continues to support PGCPS in its celebrations in North, Central and South County.

Objective 1.2: To expand high-quality multi-cultural programming to the residents of Prince George's County with focus on Arts Deserts and under-represented populations.

Update: Community Grants Program: Thanks to partial restoration of FY 2024 funding of \$100,000 from the County Council and a \$50,000 FY 2023 National Endowment for the Arts \$50,000 grant, in FY 2024 PGAHC held its full FY 2024 Community Grants Program, after a 2-year hiatus due to loss of funding. This year PGAHC received over \$455,000 in requests and awarded 30 grants to arts organizations and artists representing all County Districts and arts disciplines totaling \$150,000.

The community grants program is one of PGAHC's most impactful and important programs because it:

Invests in the creation and expansion of innovative programs and initiatives that have significant impact for years in the County community. (See Neuro Blooms example above.) By design, the program has community impact in the County as a priority ranking factor leverage additional funding and economic opportunities for creatives. 70% of the FY 2024 grants serve the entire County population, including underserved populations. 47% serve underserved populations and communities, including the disabled community (goal was 35%) 50% of Artist Fellowships are new grantees.

Co-working days to provide in-depth hands-on assistance for artists and organizations to craft grant applications and other services. This is a program we want to expand in other locations in under-represented areas to encourage greater participation and more competitive applications.

ARTS EXPERIENCES:

Addison Road Creative Placemaking – This project is set to take place on April 20th at the Seat Pleasant City Hall. This program began in Spring of 2022 in partnership with LISC, The Capital Market, and community members in Seat Pleasant and Capital Heights as a creative placemaking and public art initiative at Addison Plaza, along the Blue Line Corridor – Addison Road Metro location. However, Addison Plaza withdrew its support, and the project stalled. However, the committee led by LISC and PGAHC reconvened in the Fall of 2023 and developed a new plan, now lead by PGAHC, and further described in Question 16.

The Office of the Poet Laureate has held signature events at Arts'tination - A Poet's Day Party in October and has held events at the Bowie, New Carrollton and Largo-Kettering branches of the Prince George's County Memorial Library Systems.

Juneteenth Freedom Day Celebration at National Harbor 2024 -Since 2022 PGAHC has partnered for with National Harbor, in Oxon Hill, Maryland to produce the Juneteenth Freedom Day celebration at National Harbor on June 19th featuring dynamic performing arts organizations, poetry, film and live music. Held on the National Harbor's Plaza main stage, this program was the first of its kind and grew from 250 attendees to over 500-600 people of all ages and backgrounds at our 2023 event. Most importantly, it draws mostly residents and families from the immediate and surrounding communities in South County. Surveys showed that attendees felt they learned more about our history through Juneteenth, but also loved the inclusive celebratory atmosphere for a program that felt "just for them." PGAHC will partner once again with National Harbor for FY 2024.

Goal 2. To advance arts-centered economic development through beautification initiatives, revitalization programs and services to the County's creative community and industry sectors.

STATUS: PGAHC has been focused on using the arts to revitalize neighborhoods and public spaces through creating placemaking initiatives, PGAHC Film Office, and support for the creative business industry sectors.

Objective 2.1: Transform/revitalize neighborhood and public spaces in the County through public art projects, creative placemaking initiatives, and community engagement.

STATUS 2.1: In FY 2024 through public arts projects, creative placemaking initiatives, and community engagement PGAHC has completed seven new public art installations, inclusive of under-represented areas and two are in progress. 50% of the projects are in under-represented areas to revitalize and beautify these areas and amplify empowering community engagement.

Public Art Installations include two at Bladensburg Branch Library; a mural at Otis Street Lofts; three Bus Shelters Addison Road Metro as part of our MOU wit WMATA, to help beautify shelters which were in very poor condition; and an exhibit at the Wayne K. Curry Tech Lounge. In progress installations include Bus Shelters in the City of Seat Pleasant at

Addison Road and Central Avenue, and the City of Bowie at Benjamin Tasker Middle School.

Creative Placemaking: PGAHC also participated in the Downtown Large Creative Placemaking event in August and is leading the Addison Road Seat Pleasant Creative Placemaking event on April 20, at the Seat Pleasant City Hall which is described in additional detail in Question #16. This has involved significant community engagement.

PGAHC has been an active partner as part of the Blue Line Corridor cultural and community engagement planning and implementation programs and other transit-focused projects in the County.

Objective 2.2: To increase film, television, and entertainment industry projects in the County.

STATUS 2:2: In FY 2024 PGAHC Film Office has increased capacity building and technical support for the film industry sector by supporting 29 projected County-based film projects and implemented the Reel Scout platform which will increase capacity of information gathering and site sharing within the Prince George's County film industry.

The Film Grant Program launched in April of 2022 funded by the County's ARPA grant received over \$2.245 million in grant application requests in two rounds of grants, and awarding \$263,000 in awards, showing the critical need for financial support for filmmakers. PGAHC is planning a 3rd Round this Spring. Three Film Grant Awardees completed film projects featured at the Prince George's Film Festival: Take 2 last September. All productions were filmed in Prince George's County utilizing more 90% of county resources and business.

Prince George's Film Festival: Take 2: Over 2340 attendees from 19 states participated across in-person and digital platforms a 400% from the 2022 Festival. Expanded programing over 5 County venues. 20% Increase in film submissions with Prince George's County Filmmakers taking 4 of awards. The winner of the student film category with a Prince George's Community College student. Significant media was generated from multiple media platforms (over 30 in print, radio, television and digital); and our social media platforms received nearly 400,000 impressions.

Additionally, three of Prince George's Film Office Round 1 Grant Recipients movies held Movie Premieres during the event -- "Million to One" - 8 Picture House: "The Deadly Getaway - Mega Mind Media, and "Feather" - Motion Pixel Media.

A free follow-up screening additional screening was recently held early this year. Matinee With Myles – "ORIGIN" Preview Screening – January 2024 – partnership with Bowie State. The event attracted a diverse audience of over 250+, including residents from various socioeconomic backgrounds, ages, and cultural identities. The film screening, titled "ORIGIN," was meticulously selected to resonate with the diverse demographics of our county and to promote inclusivity and understanding among our residents. This event included a Talkback with Tony Award-winning actor, Myles Frost allowing, attendees to

deepen their understanding of the subject matter explored in the film. Through the art of cinema, the film screening provided a platform for cultural exchange and appreciation. It highlighted perspectives and narratives that are often underrepresented in mainstream media, broadening horizons, and deepening cultural awareness among Prince George's County's residents and community members.

Objective 2.3: To increase capacity building and technical support for the Creative Business industry sector, DPARK 3311 (Design Park) and Arts'tination at Nation Harbor.

STATUS 2.3: In FY 2024 PGAHC has facilitated over 20 workshops and programs within the community through DPARK3311, Arts'tination and other locations for artists and residents serving over 850 people to date, including programs by the Office of the Poet, film screenings, technical assistance workshops and training. Specific details for each program are below:

ARTS'TINATION: In partnership with National Harbor, Arts'tination has been fully operational since May of 2021, and has continued to exceed our arts-focused economic impact goals for this initiative. In FY 2023 it had over 10000 visitors. Many resident artists and exhibiting artists have experienced robust sales of their artwork at Arts'tination, and on their personal e-commerce platforms, as well as experienced increased traffic on their websites. Many have expanded their small businesses to other venues and art shows because of the exposure. Since its inception, Arts'tination has enabled resident and exhibiting artists/artisans to generate hundreds of thousands of dollars in revenue through Arts'tination and in direct sales on their platforms. Arts'tination generates approximately \$125,000 in sales (before 30% commission to the artists). PGAHC generated revenue from artist fees, commissions, rentals and merchandise, to pour back into operations. Participating artists/artisans come from every Councilmanic District in the County. Arts'tination also established a partnership in April 2022 with the Prince George's County Memorial Library System to have a mini-Pebble Pop-Up Library mentioned previously within the space which provides a circulating collection and joint programming in correlation with the Oxon Hill Branch Library. Venue also has hosted local author book signings, local film maker premieres, cultural events for residents of all ages, such as the Taste of Ghana, the Poet's Day Party, and business networking events including Prince George's Chamber of Commerce.

DPARK3311, our creative incubator, has ramped up its programs and services and is preparing for its next cohort of designers-in-residence in Summer of 2024. We have held 4 workshops and 3 training sessions including the teacher training for the YAMZ program, two technical assistance co-working full day sessions for artists to come in and receive hands-on assistance with grant preparation. The media rooms and conference space are being utilized by members. The space has also been used for costume design and wardrobe planning for a film being shot in Prince George's County. Our partnership with the City of Mt. Rainier is developing new technical assistance content for the creative community in the Gateway Arts District and the County.

Please identify any factors, conditions, and trends that have either enhanced or limited the organization's ability to achieve expected and desired results. Please also discuss how the organization has responded to these factors, conditions, and trends and provide an assessment of how effective these actions have been.

Funding PGAHC's Community Grant Program - This program provides critical funding for our creative community and is the primary and sole source of funding specifically for individual artists and arts and humanities organization continues to be an extremely impactful program. After a two-year hiatus due to lack of funding, the full program was offered this year. The trends of our grant program show these grants have a much longer and larger impact on the artists and art organizations, as well as the communities they serve and the County as well.

Impact of grantees residing in one District is most often not limited to that District. 70% of our grantees serve residents and youth from across the County. Some grants are to serve communities in under-represented areas.

Our work to diversify applications and grants throughout the County is working as we are seeing an increase of applications in targeted areas.

Direct technical assistance via co-working days significantly improved the applicant's chance of funding and confidence to apply. We would like to expand these co-working days into targeted locations in partnership with the Councilmembers.

Arts and Heath projects accomplish and significantly impact several major County
priorities in education, behavioral, physical and public health, public safety and
wellness/recovery for special populations. We have several artists and organizations
working in this field and with special populations and would like to expand funding
for these programs.

Funding for the Prince George's Film Office:

Funding for the Prince George's Film Office has almost a 5-10:1 return on investment. The ongoing services for locations, the Film Grant program, and the Film Festival leverage significant revenue for the County, for the grantees, as well as exposure for Prince George's County as a destination for film production and growth. Bringing on the Director position full time, initially made possible by the ARPA Grant in the first year of funding in FY 2022 has been an essential component of this success.

Funding for the Director position is still a critical issue for us, as it has need been provided through the County after the first year. We hope the County will provide funding for this position to maintain the incredible momentum it has experienced over the past 2 years. We are gearing up for the third round of grants, and the 3 annual festival PGFF: Take 3 in September.

- 13. PGAHC mentioned during the FY 2024 Budget Review that they awarded ten (10) grants in one category (Arts in Education) totaling \$32,000. How have these grants helped achieve the goal of providing County residents and visitors with high-quality arts experiences, cultural engagement, and humanities programming with a focus on equity and inclusion?
 - a. Please provide numbers relating to these programs' ability to reach the public and the impact they have had.

The 10 grants (listed below) awarded in FY 2022 for FY 2023 programs, which focused on arts education for K-12, were incredibly impactful and far-reaching and served over 4,000 youth throughout the county. 40% of these grantees were in targeted under-represented districts, and ranged from Artist residencies, afterschool programs, and public creative placemaking community gatherings for youth and their families. As mentioned previously, most of our grantees serve and have impact not only in the immediate communities where they live/operate but serve youth and their families, in surrounding Districts and County-wide. Moreover, in FY 2023, PGAHC partnered with the Prince George's County Public Schools to have four of these grantees provide professional development training in arts integration and socio-emotional learning based on their grant funded projects to over 100 PGAHC teachers throughout the County. The grantees and their programs had a 90% -95% student and teacher satisfaction rate on their projects.

The following arts experiences were repeated in CY 2023.

Festival of Literary Arts (FOLA)

FOLA brings together local authors, poets, and storytellers from diverse backgrounds to share their work, engage in thought-provoking discussions, and inspire audiences of all ages. The festival features a dynamic lineup of readings, panel discussions, book signings, and interactive activities designed to ignite a passion for literature and foster a deeper appreciation for the written word.

Arts and Wellness Event

PGAHC's Arts and Wellness event serves as a testament to the transformative impact of arts and culture on individual and community health. Arts and Wellness is a day-long celebration that brings together local artists, performers, and wellness practitioners to offer a diverse range of activities and experiences aimed at nurturing the mind, body, and spirit. From guided art therapy sessions and yoga workshops to live music performances and mindfulness activities, this event provided attendees with opportunities to explore the healing power of the arts and engage in practices that promote physical, emotional, and mental well-being.

- a. Juneteenth Freedom Day Celebration at National Harbor
 - i. The Juneteenth Freedom Day Celebration is a vibrant and inclusive event that commemorates the emancipation of enslaved African Americans and celebrates the rich heritage and resilience of Black culture. Hosted in partnership with Peterson Companies/National Harbor, this event features live music performances, cultural presentations, interactive art installations, and educational activities that honor the legacy of Juneteenth and promote unity and social justice.
- b. Prince George's Film Festival
 - i. The Prince George's County Film Festival serves as a platform for highlighting local and independent filmmakers. Held annually, this event brings together filmmakers, industry professionals, and movie enthusiasts for a captivating exploration of the human experience through film. From thought-provoking documentaries to captivating narratives, the festival features a curated selection of films that reflect the diversity of voices and perspectives within Prince George's County. The Prince George's Film Festival is purposed to bolster filmmakers' toolkits with resources and connections to advance their career. Additionally, the Prince George's Film Festival highlights Prince George's County as a viable production location for emerging and veteran filmmakers alike.

- 1. Offered 15 panel discussions and workshops with industry experts.
- 2. Provided a platform for over 106 films submitted for consideration.
- 3. Contracted 12 local vendors to provide various support services.
- 4. Highlighted 4 Prince George's County venues.
- 5. Provided internship opportunities for local college/university students.

c. Arts'tination Workshops

i. The art-focused workshops offered at Arts'tination serve as inclusive and accessible platforms for community members to explore various artistic mediums, techniques, and concepts under the guidance of skilled instructors and local artists. The workshops cover a wide range of artistic disciplines, including painting, drawing, sculpture, printmaking, mixed media, and more. Participants in these workshops engage in hands-on learning experiences that encourage experimentation, self-expression, and skill development.

d. Creative Placemaking - Largo Fest (new)

i. This innovative approach to community development harnesses the power of arts and culture to transform public spaces, foster community engagement, and drive positive social change. This event provided opportunities for residents to share their ideas, aspirations, and concerns for their neighborhoods along the Blue-Line Corridor. By fostering open dialogue and collaboration, this event empowered residents to actively participate in shaping the built environment and cultural identity of their communities. Through public art installations, temporary exhibitions, performances, and creative interventions, residents were invited to experience and interact with their surroundings in new and meaningful ways, fostering a sense of pride and ownership in their neighborhoods.

e. Office of Poet Laureate - Poet's Day Party (new)

i. The Poet's Day Party is a celebration that honors the literary achievements of local poets, writers, and spoken word artists while providing a platform for community members to come together and celebrate the power of poetry to inspire, uplift, and unite. This event displays the diverse talent and creative voices of poets within Prince George's County, recognizing their contributions to the literary arts and highlighting the importance of poetry as a form of expression and cultural heritage.

- f. Film Screenings "Mercy Road," "The Crown," and "The Flip Side" (new)
 - i. PGAHC and Prince George's Film Office's film screenings serve as a platform for highlighting local and independent filmmakers' cinematic excellence, exploring diverse perspectives, and promoting dialogue on social, cultural, and historical themes. Many of the films featured in our screenings are filmed within Prince George's County, highlighting the talent and creativity of local filmmakers, actors, and production crews. By showcasing these films, we celebrate Prince George's County's unique cultural identity and contribute to the growth and recognition of our local film industry.

PGAHC's decision to repeat these art experiences was deliberate and stems from several important considerations.

- Community Engagement and Feedback: The repeated art experiences events were selected based on overwhelmingly positive feedback and demand from our community members. These events or exhibitions were well-received in the past, drawing significant attendance and participation. Therefore, PGAHC prioritized meeting the desires and interests of our community members by offering these experiences again.
- Cultural Preservation and Promotion: Some art experiences hold significant cultural or
 historical value for Prince George's County. By repeating these events, PGAHC aims to
 preserve and promote our cultural heritage, ensuring that residents have continued
 access to important aspects of their identity and history. These experiences contribute
 to the enrichment of our community's cultural tapestry and serve as platforms for
 intergenerational dialogue and understanding.
- Educational Opportunities: Certain art experiences provide valuable educational
 opportunities for residents of all ages. Whether through workshops, exhibitions, or
 performances, these events offer insights into various artistic mediums, techniques,
 and cultural contexts. By repeating these experiences, we enable ongoing learning and
 skill development within our community, fostering creativity and innovation.
- Economic Impact: The arts and cultural sector play a crucial role in driving economic
 activity and tourism. Repeating successful art experiences helps sustain and grow this
 sector, attracting visitors from neighboring counties or states and supporting local
 businesses. Additionally, these events may generate revenue through ticket sales,
 merchandise, or concessions, contributing to the overall economic vitality of our
 county.

- Inclusivity and Accessibility: PGAHC recognizes the importance of ensuring that art experiences are inclusive and accessible to all members of our community. By repeating certain events, we strive to provide multiple opportunities for residents to participate, accommodating diverse schedules and preferences. Furthermore, we endeavor to make these experiences physically and financially accessible, offering free or low-cost options and ensuring venues are wheelchair accessible and equipped with necessary accommodations.
- 15. During the FY 2024 Budget two events were mentioned to be planned in FY 2023 for South County Programs. Did the events take place and what impact did they have on addressing Art Deserts and under-represented populations?

Oasis for the Arts (South County strategy) - In collaboration with the Brandywine Revitalization Committee, the first of two events planned for FY 2023 was held in daylong event October 22, 2022, "Oasis For The Arts: Celebrating Our Community, It's History, and The Land" at the Patuxent Riverkeepers House in Upper Marlboro to recognize the County's rich arts/cultural assets and programs grounded in the County's history, geography and natural resources in our rural areas. Key Activities: the community created and painted several totems with artist Caryl Henry Alexander, illustrating the nature and culture of "Oasis Water Stories; a land acknowledgement of the County's indigenous occupation and history of slavery; a water blessing recognizing in the County's indigenous cultural traditions, blacksmith demonstrations by a 4th generation African American blacksmith and riverkeeper, stories, juggling, food and music.

The 2nd phase of the program, including installing the Community totems painted at the first event, was planned for May 2023. It has been stalled due to lack of funding. Our hope is to identify funding and additional support and resume the planning for this project.

16. Was the Addison Road Plaza creative placemaking project scheduled to take place during Spring-Fall 2023 completed? If not, why not?

No. Horning Brothers, the property owners of Addison Road Plaza after a year of planning meetings decided to dis-engage from any place making strategies including the planned clock tower public art enhancement and creative incubator space in the originally offered vacant retail space. This did not deter PGAHC from moving forward. Leveraging our MOU with WMATA, PGAHC installed 4 temporary public art bus shelters at Addison Road Metro receiving immediate accolades from riders and the community. PGAHC also is leading a Seat Pleasant community placemaking activity on April 20, partnering with various community stakeholders including the City Council, anchoring non-profits, and local creatives.

PGAHC's performance indicators and measures ensure its core values, mission and strategic objectives outlined Question 12 are being met. Performance indicators focused on our core values for each division and staff person include Accountability, Adaptability, Clear Communication and Collaboration, Initiative, Valuing Diversity, Managing Resources, Organization/Project Management, and Technology. Each division has goals and objectives tied to those outlined in Question 12. Each division works collaboratively to ensure PGAHC meets its main performance measures outlined in Question 12. Please refer to Question 12 for details on corresponding objectives.

Community Grants Program and other Grantmaking – PGAHC is the legislated arts agency for the County and administers a variety of grant programs for individual artists, arts organizations, and other entities including the County's signature Community Grants Program including artist fellowships, County arts organization, Arts in Education, public art, and creative placemaking. This program also administers special initiatives like the Community Voucher Program and provides technical support to other PGAHC grant and juried programs utilizing the grants platform. Key performance measures are tied to both Goals and related Objectives, 1.1 and 1.2 and indirectly through workshops, advocacy and training Objectives 2.1-2.3. Additional measures include grant writing goals, compliance and accurate and timely stakeholder reporting on funding received.

Public Art - PGAHC administers the County's Arts in Public Places (AIPP) program on behalf of the County's Office of Central Services as well as other public art and creative place making programs throughout Prince George's County. PGAHC also administers the first Maryland State Certified Public Art Apprenticeship Program.

The public art program also leads arts-centered economic development programs creative placemaking initiatives and programs in collaboration with other PGAHC divisions and public and private partners. The programmatic components are managed through the Public Art and Creative Placemaking division. PGAHC operates two facility-based arts incubator programs for small creative businesses including DPark331 (Design Park 3311) and Arts'tination at National Harbor. PGAHC is also an agency lead for upcoming arts and cultural activations on the Blue Line Corridor.

Key performance indicators are indicated in underrepresented areas "Arts Deserts" in Objective 1.2 and in Objective 2.1 to transform/revitalize neighborhood and public spaces.

Programs: This division leads all programs and key special initiatives including our Arts and Social Practice Programs and our Arts in Education programs. Arts in Education programs are one of the highest priorities for PGACH and a core program. This division has oversight of several other programs and services indicated below, which are designed with an equity lens to target underserved populations and regions, including the program components of DPARK3311 and Arts'tination. The program division also provides support for the Office of the Poet Laureate. This division has metrics tied to both Goals and related objectives with a focus on Objectives 1.1 and 1.2 and Objectives 2.1 and 2.3.

Office of the Poet Laureate - PGAHC established and administers the Prince George's County Office of the Poet Laureate which focuses on literary arts and culture by promoting literacy in the community and a countywide appreciation of poetry. Through engaging programs and services for County residents and youth, the Office of the Poet Laureate supports a series of community activities with a concentration on initiatives that support and sustain the cultural life of Prince George's County. Key programs are the Festival of Literary Arts (FOLA), and the inaugural Poetry Anthology. This program relates to Goal and Objectives 1.1 and 1.2 and supports also Objective 2.3 programmatically.

Prince George's Film Office - PGAHC established and administers the Prince George's Film Office which promotes the advancement of the film and digital media industries in Prince George's County. As Prince George's County continues to blossom as a premier filmmaking destination, the Prince George's Film Office serves as a resource center to film and production teams for site logistics and permits, funding through the Film Office's grant program, and professional development through the Prince George's Film Festival. The Film Program directly correlates to Objective 2.2 and 2.3 as an economic driver in the County. It also covers Objective 1.1 and 1.2 targeting underserved constituencies and bringing high quality accessible arts programming.

PGAHC is sourcing contractual expertise as a temporary solution to inadequate staffing levels across all our divisions including Fundraising, Facility -based Programming, Creative Place-Making, Film Office, and Marketing. This strategy will continue through FY 2025

ENHANCEMENT REQUEST FOR CRITICAL STAFFING NEEDS:

Overall, our agency is critically understaffed given our countywide service and increased deliverables and responsibilities in ore areas. Regionally, the staff levels of comparable arts councils average 12 FTE positions. We have focused on 1 existing and 3 new positions that will create immediate impact and lessen the immense workload on the Executive Team and sustain areas of increasing demands that will only increase with the County's stated new initiatives including, the Cultural Action Study and Plan Development and the new Cultural Arts Center.

Film Office General Manager and Business Developer – \$104,800(salary and fringe) PGAHC is requesting dedicated funding for this essential position who has been responsible for our demonstrated local film industry growth, increased film productions, film grant management and successful Prince George's Film Festival. This position was not covered by FY 2023 ARPA(Year 2) funding but is funded in FY 2023 by one-time relief funding from the Maryland State Arts Council. It is critical for the County to provide funding. This position works closely with OCS and EDC and oversees all film office service areas including but not limited to county site selection, permitting assistance, production company negotiations, technical assistance programs, screenings, REEL Scout web platform management, film festival management, and community outreach. The return on investment is significant, as this program is a revenue generator for the County. Also, should the County be awarded additional Film Tax Incentives, this position would administer that program.

FY 2024 MAJOR PGAHC PROGRAM OBJECTIVES

Community Grants Program

Potential New: Arts and Wellness – As mentioned in Question 12, this category is a growing trend and evidence-based field and addresses so many County priorities in wellness, public health and safety. We have County artists and County organizations that are skilled in this area, and we would like to support expanding the funding.

Prince George's Film Office

In the Fall of FY 2025 the office will produce its third County-wide Film Festival, Take 3, with the purpose of increasing and enhancing the branding strategy of Prince George's County as the regional filming destination. PGAHC did not receive any additional ARPA funding in FY 2024, which is the sole source of funding for this program. This funding provides critical support for all aspects of the Film Office - the new film grant program, the FY 2025 film festival and technical assistance programs.

Prince George's Film Festival - \$100,000 To produce Take 3 in FY 2025. Prince George's Film Festival-Take 2 (October 2023) provided critical technical assistance for our local film community through panel discussions, workshops, and juried film screening opportunities for over 2000 participants across our various platforms. The event also garnered significant media attention as well. Overall programming assessment exceeded expectations as documented by participant surveys. The funding requested will be base funding which will be leveraged for additional sponsorship revenue.

Art in Public Places/Creative Placemaking

Blue Line Corridor Public Art Strategy

Working within the County's priority economic development strategy PGAHC has secured Maryland Capital Grant and NEA funding to develop and implement an impactful public art strategy that includes McCormick Drive, UMD Regional Medical Center Garage, Largo Metro Station, and Addison Road/Central Avenue Corridor County CIP and Major Renovation Projects

NEW - Blue Line Corridor Central Library and Cultural Center - Planning - PGAHC in collaboration with PGCMLS is a lead agency in the development and execution of this anchoring capital project. Operational focus will be on community outreach, design, and developing a capital campaign and sustainability strategy. Continued project management services for OCS and expansion of Environmental Public Art Program in collaboration with the Department of the Environment.

Targeted Communities -

South County - Implementation of key projects in South County with the Brandywine Revitalization Committee and community organizations.

Central County - Addison Plaza/Addison Road – Implementation of public art (bus shelter at Addison Metro and at Addition Plaza) in Seat Pleasant/Capitol Heights regions. Long term feasibility for capital project to nurture and grow the creative community in Central County.

Arts in Education

As described in Question 12, PGAHC launched two new programs, YAMZ (Young Artists and Musicians Zone) and Neuro Blooms which serves K-12 children in the Prince George's County School systems. In FY 2025 We would like to expand these programs into other schools, with a target on under-performing community schools.

We also want to provide the teacher professional development workshops for teachers and administrators which were extremely successful in the Winter and Spring of 2023.

Facility- Based Initiatives

Arts'tination at National Harbor – Focus on small business development and technical assistance for our local creative industries.

DPARK 3311 Creative Co-Working Space - Gateway Arts District - Focus on small business development and technical assistance for our local creative industries.

NEW - Office of the Poet Laureate - South County - Assist literary community in developing a capital project strategy for a much-needed Writers Center Capital Project. The program and revenue strategy includes a published Anthology of Local Poets

Scope and Importance: The reliance on a single or limited funding source can pose significant risks to the financial stability and sustainability of the PGAHC. Diversification of funding sources is crucial to ensure that the organization can continue to fulfill its mission and deliver its core programs effectively.

Current Status: PGAHC currently relies heavily on county funding and grants and allocations as its primary source of funding. While these funds provide essential support, they may be subject to fluctuations, highlighting the need for diversification.

Plans to Address: PGAHC is exploring opportunities to diversify its funding sources by seeking partnerships with private donors, corporate sponsors, and philanthropic foundations. Additionally, efforts are being made to increase revenue through aggressive fundraising events.

Obstacles: One major obstacle is the competitive nature of securing funding from alternative sources, especially in a challenging economic climate. Additionally, building relationships with potential donors and sponsors requires significant time and resources.

Budget and Operational Implications: In the short term, diversifying funding sources may require upfront investment in fundraising efforts and staff capacity building. However, in the long term, it can mitigate financial risks and provide greater financial stability for the organization.

Potential Actions: PGAHC is exploring various strategies, including implementing targeted fundraising campaigns, cultivating relationships with potential donors, and exploring opportunities for earned revenue generation through fee-based services and events.

Critical Issue 2: Community Engagement and Outreach

- Scope and Importance: Strengthening community engagement and outreach efforts is critical for expanding the PGAHC's reach, increasing public awareness and participation in arts and humanities activities, and building support for its mission.
- Current Status: PGAHC conducts various community engagement activities, such as workshops, events, and collaborations with local schools and community organizations. However, there is room for improvement in terms of reach and effectiveness.
- Plans to Address: PGAHC is developing a comprehensive community engagement strategy that includes targeted outreach efforts, partnerships with community stakeholders, and innovative programming designed to meet the diverse needs and interests of residents.
- Obstacles: Limited resources, including staff capacity and funding, can hinder the organization's ability to implement robust community engagement initiatives.
- Budget and Operational Implications: Strengthening community engagement efforts may require investment in staffing, marketing, and outreach materials. However, increased community participation and support can lead to greater program impact and sustainability.
- Potential Actions: PGAHC is strengthening partnerships with local businesses, agencies, schools, and grassroots organizations to expand its outreach efforts. Additionally, leveraging digital platforms and social media can enhance the organization's online presence and reach a wider audience.

We have directly engaged several municipalities through ongoing creative placemaking planning and activations, being a resource for identifying and providing technical assistance for arts grant opportunities in addition to our own Community Grant Program and taking on the interim role of Administrative Agency for the Gateway Arts District. Municipalities (incorporated and un-incorporated) that have been impacted are, City of Bowie, Laurel, City of Seat Pleasant, Fairmont Heights, Capitol Heights, Largo, Town Brentwood, Town North Brentwood, Mount Rainier, Town Upper Marlboro, Suitland, Oxon Hill, and Brandywine, with the list continuing to expand.

The Prince George's County Cultural Plan lacks the platform and staffing for sustainable coordination and sufficient funding allocation for achieving consistent benchmarks and full implementation. PGAHC continues to work with local communities and with our agency partner M-NCPPC to engage recommendations derived from the Cultural Arts Study and achieving short term goals presented.

PGAHC is advocating for funding support through the Maryland General Assembly for the Prince George's Film Office within a larger commitment by Governor Wes Moore and Maryland Department of Commerce to elevate Maryland as a Film and Entertainment destination.

PGAHC PARTNERSHIPS INFORMATION:

PGAHC has proactively entered strategic partnerships with an MOU to strengthen our ability to accomplish our strategic goals and mission. These partnerships have allowed PGAHC to pursue collaborative environments for programs and facilities.

Bowie State University, Department of Fine and Performing Arts: This MOU formalizes a long-term collaboration, student, faculty and community engagement relationship to sponsor events and programs that strengthen and expand workforce pipeline initiatives in the visual, performing arts, film and entertainment industries. Both students and faculty are engaged which areas include visual communication, advertising design, digital media, media arts, design, film, animation, fashion design); and assist with professional artistic events, opportunities on campus and to also connect students with internship and career opportunities off-campus. Recent initiatives include BSU Goes to Broadway in March 2022, which we brought 55 students to New York City to see Miles Frost in MJ The Musical, a talk back with Miles and networking reception. Miles later won an Emmy. The first Prince George's County Film Festival was also a partnership that engaged faculty, BSU facilities, and over 20 student interns and volunteers.

Gateway Community Development Corporation – This MOU will allow PGAHC to accomplish its goals to provide Prince George's County residents and visitors with diverse and high-quality arts experiences, cultural engagement, and humanities programming with a focus on equity and inclusion. The MOU engages a collaborative environment with municipalities via programs and facilities known as Gateway Media Arts Lab and DPARK 3311.

Gateway Arts and Entertainment District - This agreement assigns PGAHC as the management agency of record to facilitate the development a new Gateway Arts District management structure inclusive of all four municipalities in establishing mutually beneficial policies for governance of designated MSAC Arts and Entertainment funding, collaborative programming, and developing overarching marketing and branding strategies.

Prince George's County Office of Stakeholders Engagement – This MOU outlines financial support and advocacy for the arts and humanities through grants, artistic programs, and creative partnerships among businesses, education, government, and residents. The MOU is helping to meet PGAHC's goal to advance arts-centered economic development through beautification initiatives, revitalization programs and services to the County's creative community and industry sectors. Two murals have been created.

Prince George's Community College Center for Performing Arts (PGCC CPA) – The MOU expand opportunities for performing art events to Prince George's County community by providing financial assistance to non-profit organizations and artist for rental expenses incurred when staging performances at the PGCC CPA. This MOU accomplishes PGACH's goal to expand high-quality multi-cultural programming to the residents of Prince George's County with focus on Arts Deserts and under-represented populations.

Mission of Love – The MOU will expand opportunities for participating in the arts to marginalized and vulnerable communities to facilitate a creatively engaging and vibrant arts community. The MOU targets PGACH's goal of expanding high-quality multicultural programming to the residents of Prince George's County in Arts Deserts and under-represented populations.

Prince George's County Memorial Library System - Letter of Agreement to implement the shared goals of providing access to innovative, creative community-based cultural enrichment and engagement activities that promote literacy, engagement and enhance the well-being for the residents, businesses, visitors, and communities in and surrounding National Harbor and Oxon Hill, Maryland. Key components include installation of Pebble Pop-up Library at Arts'tination, a mini library with a circulating collection in coordination with the Oxon Hill Library; library and joint programming for adults and children at Arts'tination; and collaborative creative arts programming provided by PGAHC at the Oxon Hill Library with Arts'tination resident artists and other local artists from the County.

Prince George's County Public Schools - This MOU provided collaborative programming for Artist-in-Residencies, the student exhibition and support for PGATI – a conference for teacher training and support for arts integration. The F23 Contract provides professional development creative arts integration workshops for teachers with a focus on socioemotional learning and student engagement in various disciplines and County learning priorities.

Washington Metropolitan Area Transit Authority – This MOU facilitates the selection, production, and installation for performance of public arts pieces at selected Metrorail facilities within the County. The MOU targets PGAHC's goal of transforming/revitalizing neighborhoods and public spaces in the County through public art projects, creative placemaking initiatives, and community engagement.

Experience Prince George's - PGAHC has a close partnership with Experience Prince George's (non-MOU), to provide and promote culturally based content and support to fulfill key areas where our mission and plans are aligned. As the official destination marketing organization for Prince George's County, Maryland -- Experience Prince George's -- we work together actively market the County's cultural assets and programs to promote Prince George's County (regionally and nationally) as a prime Mid-Atlantic destination for leisure travelers, residency, meetings, conventions, reunions, group tours, sporting events and special events, including our Film Festival. By collaborating on this effort, PGAHC and Experience Prince George's can emphasize the county's rich diverse cultural heritage and boast a thriving arts community that is ready to welcome businesses and visitors alike. Key areas include arts and culture focused events, Arts'tination at National Harbor, established and developing Arts Districts and our Film Office. Through the Film office programs and festival, the primary goal is to attract and encourage film industry productions in the County, and to increase number of film projects with larger budgets that include multiple overnight stays and spending within Prince George's County.

Rebranding a County Narrative: Amplifying and elevating a dynamic, inclusive County narrative that celebrates its rich cultural diversity, unique history and cultural assets, and new opportunities for dynamic creative placemaking destinations and engagement for residents, visitors, businesses, and non-profit communities. Statement of Financial Position FY 21






Where We're Going
