**RESOLUTION**

1 A RESOLUTION concerning

2           The Redevelopment Authority of Prince George's County Fiscal Year 2012

3                           Operating Budget and Capital Improvement Program

4 For the purpose of approving the Capital Improvement Program of the Redevelopment Authority  
5 of Prince George's County for Fiscal Years 2012-2017, prepared pursuant to the authority  
6 contained in Subtitle 15B of the Prince George's County Code and providing comments on the  
7 proposed Operating Budget of the Authority for Fiscal Year 2012.

8           WHEREAS, Section 15B-124 of the Prince George's County Code provides that the  
9 Redevelopment Authority of Prince George's County may propose one or more projects for  
10 inclusion in the Authority's Capital Improvement Program and that the County Executive shall  
11 transmit to the County Council for its approval by resolution or ordinance any such project  
12 approved by the County Executive; and

13           WHEREAS, the County Executive has proposed for approval four Capital Projects for the  
14 Redevelopment Authority's Capital Improvement Program which consists of project numbers  
15 UM900063 Addison Road/Capitol Heights Metro Corridor, UM900995 County Revitalization,  
16 UM900013 Gateway Arts District, and UM900985 Suitland Manor, and copies of which are  
17 attached hereto as Attachment 1; and

18           WHEREAS, Section 15B-123 of the Prince George's County Code provides that if the  
19 proposed operating budget of the Authority includes any item to be funded from payments to be  
20 received from the County that the anticipated receipts shall be identified for each item and a copy  
21 of the proposed budget shall be transmitted by the Authority to the County Executive and the  
22 County Council for their review and comment; and

1 WHEREAS, the Authority has forwarded its proposed operating budget to the County  
2 Executive and the County Council for review and comment as shown in the Appendix to the FY  
3 2012 proposed budget.

4 SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince  
5 George's County, Maryland, that subject to and in accordance with the authority of the Charter of  
6 Prince George's County and pursuant to Subtitle 15B of the Prince George's County Code, the  
7 Capital Improvement Program for Fiscal Years 2012-2017 of the Redevelopment Authority of  
8 Prince George's County, as submitted by the County Executive to the County Council, is hereby  
9 authorized, approved and adopted.

10 SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the  
11 proposed Operating Budget, Fiscal Year 2012, of the Redevelopment Authority of Prince  
12 George's County and concurs with the proposed Operating Budget of the Redevelopment  
13 Authority.
