CB-17-2004 – AN ACT CONCERNING COLLECTIVE BARGAINING AGREEMENT – INTERNATIONAL ASSOCIATION OF FIRE FIGHTERS, AFL-CIO, LOCAL 1619 (FIRE FIGHTERS, PARAMEDICS AND EMERGENCY RESPONSE TECHNICIANS) for the purpose of amending the labor agreement by and between Prince George's County, Maryland and the International Association of Fire Fighters, AFL-CIO, Local 1619 (Fire Fighters, Paramedics and Emergency Response Technicians) to provide for wage increases and certain other terms and conditions of employment for personnel classifications certified by the Prince George's County Public Employee Relations Board. Introduction of Resolutions

CR-18-2004 – A RESOLUTION CONCERNING ADMINISTRATIVE
REGULATIONS FOR THE PRINCE GEORGE'S COUNTY HOUSING
REHABILITATION ASSISTANCE PROGRAM for the purpose of amending the regulations that govern the implementation and administration of the Prince George's County Housing Rehabilitation Loan Fund established by CB-89-1973, and amended by CB-173-1974 and CR-104-1981, which has been codified as Sections 10-173.01 thru 10-173.04 of Subtitle 10 of the Prince George's County Code.

INTRODUCED

Council Resolution 18 was proposed by the Chairman by the request of the County Executive. This resolution will approve the amendments to the Administrative Regulations for the Prince George's County Housing Rehabilitation Assistance Program. The existing program regulations require the County Council's approval for all amendments to the program. These changes will improve the effectiveness of the County's housing rehabilitation activities. Council Resolution 18 was introduced by Council Member Knotts and referred to the Transportation, Housing and the Environment Committee (THE).

<u>CR-19-2004 – A RESOLUTION CONCERNING BOWIE VICINITY MASTER</u>
<u>PLAN AND SECTIONAL MAP AMENDMENT (SMA)</u> for the purpose of expeditiously implementing the Bowie and Vicinity Master Plan and Sectional Map Amendment (SMA). <u>DR-2 SUBSTITUTED; INTRODUCED</u>

Council Resolution 19 directs the schedule for preparation and adoption of the 2005 Bowie and Vicinity Master Plan "be expedited as much as possible;" directs Planning Department and Planning Board to use or develop new "land-use tools" for this Master Plan and Sectional Map Amendment; and requires that the Intercounty Connector (ICC) and its extensions, including A-44, A-58 and the Public Transportation Facility (PT-1) not be shown on the Plan. The resolution requires adoption and approval of the Master Plan and its Sectional Map Amendment (SMA) by January 2006. Council Member Dernoga moved to substitute Draft 2 in lieu of Draft 1; seconded by Council Member Harrington. The motion carried by voice vote. Absent: Council Members Bland and Hendershot. Council Resolution 19 Draft 2 was introduced by Council Members Dean, Peters, Exum, Knotts, Dernoga and Harrington and referred to the Planning, Zoning and Economic Development Committee (PZED).

Council Member Exum moved adoption of the Consent Agenda; seconded by Council Member Dean. The motion carried by voice vote. Absent: Council Members Bland and Hendershot.
