**BACKGROUND INFORMATION/FISCAL IMPACT:**

The Maryland Sustainable Communities Program established by State law provides a process by which an area may be designated as a Sustainable Community. In order to be considered for designation, an application and proposed Action plan must be submitted to the Department of Housing and Community Development, along with a resolution of approval by the governing body of the political subdivision in which the area proposed for designation is situated. This Resolution approves the proposed designation of the Glassmanor-Oxon Hill Transforming Neighborhoods Initiative Area as a Sustainable Communities Area pursuant to Title 6, Housing and Community Development, Annotated Code of Maryland.
