The briefing convened at 2:59 p.m. Chair Ivey introduced Anya Makarova, Senior Advisor to the Board of Health, who introduced Dr. Matthew Levy, MD, MPH, Health Officer. Dr. Levy introduced Dr. Jaqueline Somerville, PhD, Associate Director, Behavior Health Division, and Samantha Karon, Program Manager, Behavior Health Division. Ms. Karon then presented a Powerpoint presentation titled "Opioid Restitution Funds". The presentation highlighted the following: Background The Opioid Crisis in the U.S.; Three Waves of Opioid Overdose Deaths; 12 Month-ending Provisional Number of Drug Overdose Deaths by Drug or Drug Class; Background: The National Opioid Settlements; Litigation Process; National Agreements Reached to Date; State and County Allocations; Requirements - National Agreements; Distribution Process; Our Approach and Progress to Date; Principles for the Use of Funds From the Opioid Litigation; Best Practices for Creating a Settlement Council; Prince George's County Opioid Abatement Task Force; Activity to Date; Recommendation-Making Process; Decision-Making Process and Current Status. Ms. Makarova then presented a Powerpoint presentation titled "Update of the Opioid Restitution Funds: Additional Information". The presentation highlighted the following: Settlement Overview; Maryland Finalized Settlements; Allocation of Janssen Settlement and Walmart/Walgreens/Allergan/Teva Settlements' Funds; Total Maryland Funding; State Opioid Restitution Funds Allocated and Expended to Date; How much funding did Prince George's County receive; Additional Settlement Details; Use of Opioid Restitution Funds; Opioid Restitution Fund use of funds: State Finance and Procurement Article 7-331 and Opioid Restitution Fund Advisory Council. The panel guests along with Ms. Makarova responded to questions from Council Members.
