##### PUBLIC SAFETY AND FISCAL MANAGEMENT

Committee vote: Favorable, 3-0, (In favor: Councilmembers Peters, Dean and Knotts.)

This resolution will amend the Salary Plan in Salary Schedule H for employees in the International Association of Fire Fighters (IAFF), AFL-CIO, LOCAL 1619 (Civilians) and will reflect modifications of the two-year Agreement. (July 1, 2005 - June 30, 2007.)

**BACKGROUND INFORMATION/FISCAL IMPACT:**

This is companion legislation to the bill to approve the collective bargaining agreement between Prince George's County, Maryland and the International Association of Fire Fighters, Local 1619, AFL-CIO (Civilians) for Fiscal Years 2006 and 2007. This resolution reflects modifications of the agreement. A fiscal impact statement will be provided by the Office of Management and Budget.

The proposed salary plan amendments were submitted to the County Council by the County Executive on May 30, 2006. Pursuant to Section 903 of the Charter, if the Council fails to take final action on the proposed salary plan before July 29, 2006, the salary plan shall stand approved.
