ZONING BILL

AN ORDINANCE concerning

Homing or Racing Pigeons

FOR the purpose of permitting the keeping of pigeons by Special Exception in the R-55 Zone and providing for the regulation of their keeping in all zones where permitted.

BY repealing and reenacting with amendments:

Sections 27-441 (b) (7), and

27-442 (i),

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that Section 27-441(b)(7) and 27-442(i) of the Zoning Ordinance of Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code, are hereby repealed and reenacted with the following amendments:
