ZONING ORDINANCE NO. 4 - 2023

AN ORDINANCE to approve a request for validation of City of College Park Use and Occupancy Permit No. 19-1301-U, issued in error on June 7, 2018, for eight (8) apartment units on approximately .25 acre of land, located in the R-18 (Multi-Family Medium Density Residential)/RMF-20 (Residential, Multifamily 20)¹ Zone, also identified as 4604 Knox Road, College Park, Maryland.

WHEREAS, the approval of Use and Occupancy Permit No. 19-1301-U was predicated on the January 24, 1960, approval of Use and Occupancy Permit No. 3692-U for eight (8) multi-family units; and

WHEREAS, in accordance with the law, the application for validation was given public notice, and a public hearing on the application was held before the Zoning Hearing Examiner; and

WHEREAS, no one appeared in opposition to the request at the hearing held by the Examiner; and

WHEREAS, the disposition recommendation of the Zoning Hearing Examiner was duly filed and considered by the District Council; and

WHEREAS, the District Council has determined that the application, to approve a request for validation of City of College Park Use and Occupancy Permit No. 19-1301-U, issued in error

¹ The 2022 Countywide Map Amendment placed the property in the RMF-20 Zone concurrently with the existing R-18 Zone. The property owner may elect to continue the R-18 Zone for two (2) years or may elect to utilize RMF-20 Zone.

on June 7, 2018, for eight (8) apartment units on approximately .25 acre of land, should be approved; and

WHEREAS, as the basis for this final action, the District Council adopts and incorporates, as if fully restated herein, the disposition recommendation of the Zoning Hearing Examiner.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED:

SECTION 1. City of College Park Use and Occupancy Permit No. 19-1301-U issued in error on June 7, 2018, for eight (8) apartment units on approximately .25 acres of land, located in the R-18 (Multi-Family Medium Density Residential)/RMF-20 (Residential, Multifamily 20) Zone, also identified as 4604 Knox Road, College Park, Maryland, is hereby validated.

SECTION 2. The eight (8) apartment units on approximately .25 acres of land, located in the R-18 (Multi-Family Medium Density Residential)/RMF-20 (Residential, Multifamily 20) Zone, also identified as 4604 Knox Road, College Park, Maryland, shall be declared a Certified Non-Conforming Use.

SECTION 3. Any violation of this approval shall be subject to revocation proceedings in accordance with the Prince George’s County Code.

SECTION 4. This Ordinance shall take effect on the date of its enactment.


