RESOLUTION

A RESOLUTION concerning

Fire Officials (MAJORS),

Salary Schedule S-I, Schedule of Pay Grades

FOR the purpose of amending the Salary Plan of the County to reflect
the new pay rates, define the workweek, and explain benefits of Fire
Officials.

WHEREAS, pursuant to Section 903 of Article IX of the Prince George's County Charter and Section 16-125(a) of the Prince George's County Code, amendments to the County's Salary Plan are to be submitted to the County Council in resolution form; and

WHEREAS, the Salary Plan must at this time be amended by the approval of a salary schedule to reflect the new pay rates for the Fire Officials; and

WHEREAS, pursuant to Charter Section 903, the County Executive has recommended and submitted such amended salary schedule to allow benefit modifications;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the salary schedule submitted and

recommended by the County Executive on May 29, 1990, which is attached hereto and made a part hereof, setting forth a modified pay plan which includes a four percent (4%) increase in the base hourly rates retroactively effective to July 2, 1989; a five and fourteen one hundredths percent (5.14%) increase in the base hourly rates and a three and one-half percent (3 1/2%) upward adjustment of the maximum rate effective July 1, 1990; a three and one-half percent (3 1/2%) upward adjustment of the maximum rate effective July 1, 1991; a seven percent (7%) increase in the base hourly rates effective July 14, 1991; a two percent (2%) wage scale adjustment of the maximum rate effective January 14, 1990, January 13, 1991 and January 12, 1992, respectively; and further establishing the workweek and number of productive hours therein, designation of meal periods, leave provisions, incentive awards, unemployment insurance, retirement contributions, uniforms and clothing, educational incentive pay, group health insurance, death and disability payments, life insurance, social security, worker's compensation, unused sick leave payment, for such employees, be and the same is hereby approved.
