# COMMITTEE REPORTS:

## TRANSPORTATION, HOUSING AND ENVIROMENT COMMITTEE

Date 6/30/2008

Committee Vote: Favorable with amendments, 4-0 (In favor: Council Members Dernoga, Olson, Bland and Harrison)

Staff explained the purpose of CR-29-2008. The Annual Action Plan allocates the maximum funding allowed by law to the eligible categories: Public Services Projects (15%) and Program Planning and Administration (20%). The remaining balance is allocated among the eligible activities: acquisition and rehabilitation, economic development, relocation and public facilities.

The Transportation, Housing and Environment Committee reviewed the Annual Action Plan, focusing on each of the above-mentioned categories and proposed changes as reflected in CR-29-2008, Draft 2. Attachment 1 indicates all amendments that reflected in CR-29-2008, Draft 2. The Committee recommended that the \$305,000 of the FY 2009 Public / Assisted Housing Rehabilitation funds be moved to: 1. Human Relations Commission - \$100,000, 2. Town of Riverdale Park - \$75,000, 3. Town of Landover Hills - \$75,000, 4. Reality, Inc - \$52,500 and Laurel Advocacy and Referral Services, Inc - \$22,500. Further more, \$182,014 funding will be moved from CDBG Administration FY 2009 to: 1. Human Services Coalition of Prince Georges County - \$82,014 and 2. The Neighborhood Design Center - \$100,000. The Committee also recommended that \$60,000 from The Prince Georges County Home Center be reallocated as follows:

- . Accessible Greenbelt Program FY 2009 \$40,000
- . Laurel Advocacy and Referral Services, Inc \$20,000

Take Charge Juvenile Diversion Program, Inc. will be receiving an additional \$3,000 from First Generation College Bound, Inc within the Public Services Category. For additional information, Attachment 1 has been provided and an amendment sheet.

#### BACKGROUND INFORMATION/FISCAL IMPACT:

This resolution will approve and adopt the Prince George's County Fiscal Year 2009 Housing and Community Development Annual Action Plan consisting of federal programs, including their federal applications which, along with other resources, serve to implement housing and community development strategies set forth in the County's FY 2006-2010 Consolidated Plan, adopted by CR-41-2005, which Plan was required by the U.S. Department of Housing and Urban Development (HUD) as a prerequisite to consideration of the funding applications. The funding applications are for the following four Federal entitlements: American Dream Downpayment Initiative (ADDI), Community Development Block Grant (CDBG), Emergency Shelter Grant (ESG), and HOME Investment Partnership Grant (HOME). The County will receive a sub-grant of Housing Opportunities for Persons with Aids (HOPWA) funds from the District of Columbia, Department of Health, HIV/AIDS Administration, the formula grantee of the Washington, DC Eligible Metropolitan Statistical Area.
