A RESOLUTION	concerning
	Designating April as "Second Chance Month"
For the purpose of	f collectively recognizing the month of April as "Second Chance Month" to
celebrate the pow	er of redemption and renewal in the lives of formerly incarcerated individuals
seeking to rebuild	their lives and thrive; raising awareness of unnecessary barriers faced by
individuals with c	riminal records; promoting policies and initiatives that remove barriers to re-
entry and help ind	ividuals with criminal records rebuild their lives and contribute positively to
society; and honor	ring those who work towards removing unnecessary barriers and support
formerly incarcera	ated individuals.
WHEREAS	, every individual is endowed with human dignity and value;
WHEREAS	, redemption and second chances are values of Prince George's County;
WHEREAS	, hundreds of thousands of individuals return to their communities from federal
and state prisons a	and local jails every year;
WHEREAS	, many individuals returning from federal and state prisons and local jails have
paid their debt for	committing crimes but still face significant barriers (referred to in this
Resolution as "co	llateral consequences");
WHEREAS	, collateral consequences for an individual returning from a federal or state
prison and local ja	ail are often inevitable and take effect automatically;
WHEREAS	, collateral consequences prevent some formerly incarcerated individuals in the
United States from	n contributing fully to their families and communities;

WHEREAS, collateral consequences have particularly impacted underserved communities

of color and community rates of employment, housing stability, and recidivism;

WHEREAS, the inability to find gainful employment and other collateral consequences inhibit the economic mobility of an individual with a criminal record, which can negatively impact the well-being of the children and family of the individual for generations;

WHEREAS, the Alsobrooks Administration and County Council have been committed to strengthening re-entry services by including re-entry as a Proud Priority, with the goal of better coordinating re-entry services and finding ways to strengthen those services through a centralized office; and

WHEREAS, the Re-entry Advisory Board (RAB) was created by Resolution CR-49-2019 to address the needs of returning citizens in Prince George's County, researching best practices and surveying County agencies and nonprofit organizations to identify gaps in services and make recommendations to the Office of the County Executive, including the creation of the Prince George's County Returning Citizens Affairs Division (RCAD) in May 2022; and

WHEREAS, RCAD is dedicated to leading the County in being a regional and national model re-entry ecosystem, providing residents released from incarceration in state, local, and federal facilities with opportunities to transform their lives and become fully engaged and productive members of the community; and

WHEREAS, the RCAD provides countywide coordination and oversight for Prince George's County's network of services for returning citizens, including coordination of services, community engagement, policy and advocacy, research, resource development, programmatic assessments and recommendations, and the creation of a "Re-entry Playbook" to guide the Division in building an ecosystem that works for returning citizens in Prince George's County; and

WHEREAS, the RCAD has convened faith leaders throughout Prince George's County to discuss strategies to help returning citizens, including securing personal documentation, supporting re-entry ministries, and creating mentoring programs. The RCAD has also launched the Pathways to Government Initiative, the Re-entry Employment Incentive Program, as well as awarded \$100,000 in grants to community-based organizations; and

WHEREAS, the designation of April as "Second Chance Month" will promote public awareness about the impact of collateral consequences; the need for closure for individuals with a criminal record who have paid their debt; opportunities for individuals, employers,

congregations, and communities to extend second chances to those individuals.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the month of April is designated as "Second Chance Month";

BE IT FURTHER RESOLVED that "Second Chance Month" honors the work of communities, nonprofit organizations, congregations, employers, and individuals to remove unnecessary barriers that prevent individuals with criminal records from becoming productive members of society; and

BE IT FURTHER RESOLVED that the people of Prince George's County are called upon to observe "Second Chance Month" through actions and programs that promote awareness of unnecessary barriers and provide closure for individuals with criminal records who have paid their debts to the community.
