Committee Vote: Favorable, 3-0 (In favor: Council Members Davis, Olson, and Campos)

Staff provided a summary of the resolution and referral comments that were received. CR-79-2014 concerns the purpose of expressing approval of the project submitted by the Ivy League Charities of Prince Georges County, Inc. This tax credit of \$25,000 will support the Ivy Renovation and Expansion Project which supports the renovation of the Ivy Youth and Family Center located in Suitland, Maryland, and will expand service offerings to disadvantaged youths and their families. The application is being submitted to the Maryland Department of Housing and Community Development for participation in the Department's Community Investment Tax Credit Program.

Eric Brown, Director, Department of Housing and Community Development, and Cheryl Petty Garnette, Executive Director, Ivy League Charities of Prince Georges County, provided testimony in support of the resolution.

The Ivy Community Charities of Prince George's County, Inc., a non-profit organization based in Prince George's County, Maryland, has applied to the Maryland Department of Housing and Community Development for approval of the Ivy Renovation and Program Expansion Project for participation in the Community Investment Tax Credit Program. The tax credits will be used to renovate the Ivy Youth and Family Center, located in Suitland, Maryland, and expand services to disadvantaged youth and families to improve their academic, cultural, health, economic and general welfare. The State of Maryland requires local legislative support for participation in the Program.
