CHAIRMAN: Moving on, we'll go to item 6 on our agenda. This is DSP-23012, Walker Mill Self Storage. It's a request for a continuance. We have Mr. Huang who is going to give the staff presentation. Mr. Gordon may have something to say representing the applicants.

And we'll turn it to you, Mr. Huang.

MR. HUANG: Mr. Chair, let me do the sound check. Can you hear me?

CHAIRMAN: We can hear you fine. Thanks for checking.

MR. HUANG: Good morning, Mr. Chair, and members of the Planning Board. For the record, I'm Emery Huang with Urban Design Section. Item number 6 is detailed site plan, DSP-23012, Walker Mill Self Storage, which requests to develop the property with 104,122 square feet of consolidated storage use with 1,250 square feet of office space, 1,750 square feet of retail or community space. And 28 parking spaces designated for RV or camping trailers as an accessory use.

The applicant has requested a continuance until May 16, 2024, to allow for additional time to conduct community outreach which with such request, the applicant has provided a 70-day extension to the Planning Board action limit which now expires on May 31st, 2024.

1 In addition, prior to the April 9th noon deadline, 2 staff received an email from Ms. Harris (phonetic sp.) which 3 is titled, "Opposition Exhibit 1". This email expresses his 4 opposition to this development because several self storages 5 are currently present in the area. Such matter will be 6 discussed and addressed at a new Planning Board hearing date 7 is provided by the Planning Board. 8 Staff recommended the Planning Board approve the 9 request for continuance to May 16, 2024.
