3	(38.1) Business Advancement and Food Access Infill: A development which
4	combines a food [and] or beverage store not exceeding 40,000 square feet of gross floor area; a
5	consolidated storage facility; may include an eating or drinking establishment, or any other use
6	that is permitted by right , or by special exception, is permitted in the C-S-C (Commercial
7	Shopping Center) Zone; and shall not include a Department or Variety Store [or Gas Station
8	uses], where:
9	(A) the proposed development is part of a revitalization project in
10	accordance with Section 27-445.15 of this Subtitle; and
11	(B) the development meets the criteria of Division 5, Part 5 of this Subtitle.
