CB-48-2003 AN ACT CONCERNING BORROWING TO FINANCE SCHOOL

PROJECTS for the purpose of authorizing Prince George's County, Maryland, to borrow money upon its full faith and credit, at any time and from time to time, in an aggregate principal amount not exceeding Forty-five Million Seven Hundred Eighty-Eight Thousand Dollars (\$45,788,000), to finance the construction, including the design, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation, repair or modernization, of school buildings in the County; prescribing terms and conditions upon which bonds issued pursuant to this Act shall be issued and sold and other incidental details with respect thereto; and providing generally for the issuance of such bonds. - INTRODUCED

Council Member Exum, as Chairman of the Public Safety and Fiscal Management Committee, provided a verbal report of the actions and recommendations of the Committee. Council Bill 48, which provides the authority to borrow an amount not to exceed \$45,788,000 for school construction projects programmed in the FY2004 Capital Budget, was favorably reported out of PSFM on 7/2/2003. Council Bill 48 was introduced by Council Members Bland, Dean, Exum, Harrington, Peters and Knotts.

CB-47-2003 - AN ACT CONCERNING THE ISSUANCE AND SALE OF GENERAL OBLIGATION STORMWATER MANAGEMENT BONDS for the purpose of authorizing and empowering Prince George's County, Maryland, pursuant to Title 3, Subtitle 2 of Article 29 of the Annotated Code of Maryland (1997 Replacement Volume and 2002 Supplement), Section 2C of Article 31, Annotated Code of Maryland (1997 Replacement Volume, 2002 Supplement), and the Maryland Water Quality Financing Administration Act, Sections 9-1601 to 9-1622, inclusive, of the Maryland Annotated Code, Environment Article (1996 Replacement Volume and 2002 Supplement) to issue and sell an amount not to exceed Four Million Four Hundred Seventy-six Thousand Dollars (\$4,476,000) in aggregate principal amount of general obligation stormwater management bonds for the purpose of providing funds for financing in whole or in part costs of the planning, construction, reconstruction, acquisition, establishment, extension, enlargement, demolition or purchase of certain capital projects set forth in the capital budget of the County for the fiscal year ending June 30, 2004, . - INTRODUCED

Council Member Exum, as Chairman of the Public Safety and Fiscal Management Committee, provided a verbal report of the actions and recommendations of the Committee. Council Bill 47, which provides the authority to issue and sell bonds in an amount not to exceed \$4,476,000 for stormwater management projects and reflects the amount programmed in the FY2004 Capital Budget, was favorably reported out of PSFM on 7/2/2003. <u>PRINCE GEORGE'S COUNTY</u> for the purpose of adding new classes of work, abolishing certain classes of work and changing grade levels for certain classes of work. - <u>INTRODUCED</u>

Council Bill 55, as proposed by the Chairman by request of the County Executive, amends the Classification Plan by adding new classes of work, abolishing classes of work that are obsolete and changing grade levels and titles of work created as a result of a classification study conducted by the Office of Personnel and Labor Relations. Council Bill 55 was introduced by Council Members Knotts, Dean and Exum and referred to the Public Safety, Fiscal Management Committee.

<u>CB-56-2003 – AN ORDINANCE CONCERNING VEHICLE, MOBILE HOME AND CAMPING TRAILER SALES AND SERVICE</u> for the purpose of extending the amortization period for certain vehicle sales lots which are less than 25,000 square feet. - <u>INTRODUCED</u>

Council Bill 56, as proposed by Council Member Peters, extends the amortization period to November 30, 2003 for uses that did not meet the requirement set forth in CB-87-2000 (DR 3) that used vehicle sales lots be a minimum of 25, 000 square feet from August 31, 2003. Council Bill 56 was introduced by Council Members Peters, Hendershot, Dean and Knotts and referred to the Planning, Zoning and Economic Development Committee. Vice-Chairman Knotts directed the Clerk to expedite scheduling of CB-56-2003.
