A RESOLUTION concerning	
	Taxicab Rates
For the purpose of implementing, on a temporary basis, certain rate increases for taxicabs	
proposed by the	County Executive.
WHEREAS, Section 20-160 of the Prince George's County Code establishes as system of	
basic rates and surcharges for taxicabs providing service originating within the County; and	
WHEREAS, basic rates for taxicab service originating within the County have not been	
increased since the enactment of CB-49-2000, which increased the basic rate from \$1.20 to \$1.50	
and increased the mileage rate from \$0.20 to \$0.25 per one-seventh of a mile; and	
WHEREAS, the County Executive has proposed legislation to increase the basic rate from	
\$1.50 to \$3.00 and the congestion or waiting rate from \$0.20 to \$0.25 per minute; and	
WHEREAS, the County Council and the County Executive desire to increase the proposed	
rates as soon as possible to provide equitable rates for taxicab service originating within the	
County similar to those in effect for the District of Columbia, Montgomery County and other	
comparable jurisdictions; and	
WHEREAS, Section 1017 of the County Charter provides that a resolution is a measure	
adopted by the Council having the force and effect of law but of a temporary or administrative	
character.	
NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's	
County, Maryland, that Section 20-160 of the Prince George's County Code is hereby amended	
as follows:

# SUBTITLE 20. TAXICABS AND LIMOUSINES. DIVISION 7. RATES AND METERS.

#### Sec. 20-160. Rates.

(a) Regular Taxicab Rates. The regular rates to be charged by taxicab drivers are as follows:

(1) [One Dollar and Fifty Cents (\$1.50)] <u>Three Dollars (\$3.00)</u> up to the first oneseventh (1/7) of a mile or part thereof traveled. A One Dollar (\$1.00) per trip surcharge is imposed on any trip that originates between the hours of 8:00 P.M. and 6:00 A.M.

(4) In addition to the mileage charge, there shall be a time charge for any time that the vehicle is stopped or operating at a speed of under twelve (12) miles per hour at a rate of [Twenty Cents (\$.20)] Twenty-five Cents (\$.25) for each sixty (60) seconds.

BE IT FURTHER RESOLVED that the amendments to Section 20-160 approved by the adoption of this Resolution shall be effective for a period of ninety calendar days commencing on the first calendar day following the adoption of this Resolution and the signing thereof by the County Executive.
