BILL

AN ACT concerning

Land Acquisition for Maryland-National
Capital Park and Planning Commission

For the purpose of authorizing the Maryland-National Capital Park and Planning Commission to acquire a parcel of land consisting of 298.6 acres more or less from J.N. Wilson Limited Partnership (a Maryland Limited Partnership), et al., for recreation purposes.

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that pursuant to the authority contained in Section 7-106 of Article 28 of the Annotated Code of Maryland, the Maryland-National Capital Park and Planning Commission is hereby authorized to acquire with monies from the Advance Land Acquisition Fund, a certain parcel consisting of approximately 298.6 acres more or less owned by J.N. Wilson Limited Partnership (a Maryland Limited Partnership); Landover Development Partnership (a Maryland Limited Partnership); and Thomas W. and Frances Wilson, husband and wife, being described as Parcel 14 (Liber 5607, Folio 073); Parcel 20 (Liber 1587, Folio 370); Parcel 28 (Liber 1587, Folio 370); Parcel 109 (Liber 1587, Folio 372); Parcel 97 (Liber 1587, Folio 372); Parcel 72 (Liber 2683, Folio 518); and Parcel 19 (Liber 1587, Folio 370); Tax Map 59, Grid F-4, and Tax Map 60, Grid A-4, B--1, and B-4, situated in Prince George's County, Maryland, Election District 13, located on the south side of Sheriff Road, generally located in the southwest quadrant of Landover Road (MD 202) and the Capital Beltway, for public use.

SECTION 2. BE IT FURTHER ENACTED that the Clerk of the Council is hereby

directed to transmit a copy of this Act to the Maryland-National Capital Park and Planning Commission.

SECTION 3. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45) calendar days after it becomes law.
