### PUBLIC SAFETY AND FISCAL MANAGEMENT

This bill will amend the County's Classification Plan by eliminating certain classes of work in Salary Schedules S, M and R and establishes a new Y Salary Schedule for the International Association of Fire Fighters, AFL-CIO, Local 1619. These changes will satisfy the collective bargaining agreement and will increase the career paths for Sworn Fire Fighters, Paramedics and Fire Fighter/Medics.
