- (A) The use is located on a lot or parcel less than three (3) acres in size;
- (B) The lot or parcel is adjacent to land in the I-1 Zone;
- (C) The property is accessed via a private easement;
- (D) The property was recommended for low density in a Master Plan or Sector Plan approved after October 1, 2006, and for which a comprehensive land use planning study was conducted by Technical Staff prior to initiation; and
- (E) A Detailed Site Plan shall be approved in accordance with Part 3, Division 9, of this Subtitle to address landscaping and buffering.
