RESOLUTION

1 A RESOLUTION concerning

2 Corrected Resolution - Specifications and Standards - 2023 Urban Street Design Standards

3 For the purpose of amending the "General Specifications and Standards for Highway and Street

4 Construction" and the "Specifications and Standards for Highway Traffic Signals" of the

5 Department of Public Works and Transportation; providing for a Corrected Resolution to remedy

6 an error in CR-68-2023 (DR-2); terminating CR-68-2023(DR-2) and its provisions on a certain

7 date; superseding CR-68-2023(DR-2) and its provisions on a certain date; and providing for the

8 retroactive effective date of this Corrected Resolution; and generally regarding urban street design.

9 WHEREAS, CR-68-2023 (DR-2) was introduced on July 5, 2023; amended in the

10 Transportation, Infrastructure, Energy and Environment Committee on September 14, 2023, and

11 September 28, 2023; and was adopted on November 14, 2023; and

12 WHEREAS, CR-68-2023 (DR-2) amended the "General Specifications and Standards for

13 Highway and Street Construction" and the "Specifications and Standards for Highway Traffic

14 Signals" of the Department of Public Works and Transportation; and

15 WHEREAS, CR-68-2023 (DR-2) contained an error; specifically, an incorrect version of

16 "Exhibit B", which did not reflect the Transportation, Infrastructure, Energy and Environment

17 Committee amendments was attached to and incorporated in the resolution; and

18 WHEREAS, it is the intent of this Corrected Resolution to remedy the error by adopting this

19 Corrected Resolution, which is identical to the text and attachments to CR-68-2023 (DR-2), except

20 that "Exhibit B" is corrected, replaced, attached, and incorporated herein; and

21 WHEREAS, Section 23-128 of the County Code provides that amendments and revisions to

1 the "General Specifications and Standards for Highway and Street Construction" and the
2 "Specifications and Standards for Highway Traffic Signals" (collectively, "Specifications") of the
3 Department of Public Works and Transportation shall be made by Council resolution; and

4 WHEREAS, there are proposed 2023 Urban Street Design Standards amendments to the
5 Specifications, as set forth in the Department of Public Works and Transportation, "Specifications
6 and Standards for Roadways and Bridges" (2007), as revised by this Corrected Resolution; and

7 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County,
8 Maryland, that the proposed 2023 Urban Street Design Standards amendments to the
9 Specifications, as set forth in the Department of Public Works and Transportation, "Specifications
10 and Standards for Roadways and Bridges" (2007), as revised by this Corrected Resolution and set
11 forth as "Exhibit A", 2023 Urban Street Design Standards, and "Exhibit B", Inclusion File, Section
12 I, which are attached hereto and incorporated herein by reference be and the same are hereby
13 approved.

14 BE IT FURTHER RESOLVED that the implementation date for the provisions of this
15 Corrected Resolution shall be June 1, 2024.

16 BE IT FURTHER RESOLVED that CR-68-2023 (DR-2) and its provisions shall terminate
17 and be of no further force and effect upon the retroactive effective date of this Corrected
18 Resolution.

19 BE IT FURTHER RESOLVED that this Corrected Resolution, and its provisions shall
20 supersede CR-68-2023 (DR-2) and its provisions upon the retroactive effective date of this
21 Corrected Resolution.

22 BE IT FURTHER RESOLVED that this Corrected Resolution, and its provisions shall take
23 effect on the date that it is adopted and shall be retroactively effective to November 14, 2023.
