5	[(1) within one-half mile of a Metrorail Line station, as measured from the center of the						
6	transit station platform;]						
7	(1)[(2)] at least 500 feet from any R-A, R-E, R-L, R-R, R-S, R-80, or R-55 Zone;						
8	(2)[(3)] at least 500 feet from any [land] recreation center, playground or trail owned by						
9	the Maryland-National Capital Park and Planning Commission;						
10	(3) [(4)] at least 500 feet from any school land uses; and						
11	(4) [(5)] at least one mile from any other medical cannabis dispensary use.
