**BACKGROUND INFORMATION/FISCAL IMPACT:**

This legislation transfers appropriations from the Contingency Appropriation Fund in the amount of \$1,740,000 to Forestville Road/Rena Road Intersection (\$1,490,000), and the Public Safety Pier (\$250,000) projects. Lastly, this legislation further includes the realignment of appropriations for various Board of Education projects in the amount of \$569,000. These appropriation realignments are needed to cover budget shortfalls in the projects receiving the transferred appropriations.
