**LEGISLATIVE HISTORY**

FISCAL POLICY & GOVERNMENT OPERATIONS COMMITTEE

DATE: 9/16/92

Committee Vote: Favorable, 6-0 (In favor: Council Members Mills, Castaldi, Casula, Fletcher, MacKinnon and Wineland).

Mobile Telesystems, Inc. (MTI) has requested the establishment of a manufacturing Subzone of the Prince George's County Foreign Trade Zone (FTZ) to be operated at the Company's Gaithersburg location in Montgomery County. Maryland has only two other FTZ grants; the City of Baltimore and the State Aviation Administration.

Approval of this legislation will not automatically establish a subzone for MTI. This resolution will only allow MTI to petition the Federal FTZ Board for participation in its program via a subzone site in Montgomery County.

There should not be any negative fiscal impact on the County as a result of adopting CR-96-1992.
