## **BACKGROUND INFORMATION/FISCAL IMPACT:**

This Bill amends Subtitle 20 of the County Code, pertaining to taxicabs and limousines. The amendments are designed to improve taxicab service for County residents and visitors and remove the regulation of limousines from County authority. Among its provisions, this Bill updates the authorizing agency; limits certain fines and punitive actions; requires proof of good standing with the State prior to taxicab license renewal and changes the selection process for chair of the Taxi Board.
