Transportation, Housing and Environment

Committee Vote: Favorable with amendments, 5-0 (In favor: Council Members Dernoga, Olson, Harrison, Knotts and Turner)

Staff explained the purpose of CR-13-2010. This resolution amends the Prince Georges County FY 2006, FY 2007, FY 2008, FY 2009 and the FY 2010 Annual Action Plans to restructure, reprogram and approve funding for the Community Development Block Grant.

The Transportation, Housing and Environment Committee reviewed the Annual Action Plans reallocations, and proposed reflected in CR-13-2010, Draft 2. Attachment B was amended as follows:

(1) BAPS to retain the funds in the amount of \$249,644, thus reducing the reprogrammed funds to a total of \$884,963.13.

(2) \$125,000 from Prince Georges County EDC were reallocated to Community Ministry Of Prince Georges County (Answer Center) for \$38,873.36 and Walker Mill CDC for \$86,126.64.

(3) that Gateway Arts District Façade will not receive \$120,000 which will go to Gateway Arts Capacity Program.

For additional information, amended Attachment B has been provided which shows all allocations.

BACKGROUND INFORMATION/FISCAL IMPACT:

This Resolution will amend the FY 2006, FY 2007, FY 2008, FY 2009, and FY 2010 Housing and Community Development Annual Action Plans to restructure, reprogram, and add new CDBG projects. This Resolution requires a minimum of one public hearing under the “County Citizen Participation Plan FY: 2006-2010,” because it changes the use of CDBG funds from one activity to another and changes the purposes of activities.
