WHEREAS, the	WSSC Capital and Operating Budgets for Fiscal Year 2011 were adopted
by the WSSC on June	16, 2010, by Resolution 2010-1874; and
WHEREAS, the l	Prince George's County Council approved the WSSC Capital and
Operating Budgets for	Fiscal Year 2011 on May 27, 2010 with the adoption of CR-36-2010; and
WHEREAS, Sect	ion 17-202 of the Public Utilities Article, Laws of the Annotated Code of
Maryland , further prov	vides that each County Council may add to, delete from, increase, or
decrease the proposed	budget supplements; and
WHEREAS, on April 27, 2010, WSSC submitted a FY 2011 budget supplement totaling	
\$26,871,050 to the Prince George's and Montgomery County Executives and County Councils,	
to fund the redemption	of WSSC's 2001 General Construction Refunding Bonds, which will
result in the avoidance of future interest payments totaling \$4,072,750; and	

WHEREAS, on May 6, 2011, the Prince George's County Executive recommended

1 support of the proposed budget supplement; and 2 WHEREAS, the WSSC has proposed that the budget supplement be funded through the 3 utilization of \$26,871,050 of unrestricted fund balance in its General Bond Debt Service Fund. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's 4 5 County, Maryland, that the budget supplement to the WSSC Capital and Operating Budgets for 6 Fiscal Year 2011 is approved by the attached Appendix 1.
