**RESOLUTION**

1 A RESOLUTION concerning

2 The Washington Suburban Sanitary Commission

3 Capital and Operating Budgets for Fiscal Year 2011

4 For the purpose of approving a budget supplement to the Washington Suburban Sanitary  
5 Commission (WSSC) Capital and Operating Budgets for Fiscal Year 2011 and the WSSC  
6 Capital Improvements Program Fiscal Year 2011 to 2016.

7 WHEREAS, Section 17-202 of the Public Utilities Article, Laws of the Annotated Code of  
8 Maryland, requires WSSC to submit Capital and Operating Budgets and any supplements  
9 thereto to the County Executives and County Councils of Prince George's and Montgomery  
10 Counties; and

11 WHEREAS, the WSSC Capital and Operating Budgets for Fiscal Year 2011 were adopted  
12 by the WSSC on June 16, 2010, by Resolution 2010-1874; and

13 WHEREAS, the Prince George's County Council approved the WSSC Capital and  
14 Operating Budgets for Fiscal Year 2011 on May 27, 2010 with the adoption of CR-36-2010; and

15 WHEREAS, Section 17-202 of the Public Utilities Article, Laws of the Annotated Code of  
16 Maryland, further provides that each County Council may add to, delete from, increase, or  
17 decrease the proposed budget supplements; and

18 WHEREAS, on April 27, 2010, WSSC submitted a FY 2011 budget supplement totaling  
19 \$26,871,050 to the Prince George's and Montgomery County Executives and County Councils,  
20 to fund the redemption of WSSC's 2001 General Construction Refunding Bonds, which will  
21 result in the avoidance of future interest payments totaling \$4,072,750; and

22 WHEREAS, on May 6, 2011, the Prince George's County Executive recommended

1 support of the proposed budget supplement; and

2 WHEREAS, the WSSC has proposed that the budget supplement be funded through the  
3 utilization of \$26,871,050 of unrestricted fund balance in its General Bond Debt Service Fund.

4 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's  
5 County, Maryland, that the budget supplement to the WSSC Capital and Operating Budgets for  
6 Fiscal Year 2011 is approved by the attached Appendix 1.
